## Statement of Objectives

The largest Indian population in Victoria is in the South Eastern suburbs, which I proudly serve as the Member for South Eastern Metropolitan Region.

Being the Member for South Eastern Metropolitan Region, I have a great understanding of the Indian community's deep cultural ties to their culture, customs, and values. The cultural festivals of Diwali, Holi, and Vaisakhi, which are fervently observed in my electorate, are ones that I truly appreciate every year.

I travelled to India to strengthen the relationship between Victoria and India, make contacts with business executives and government officials, and comprehend the shared values and interests of our governments to inform my job as their Legislative Council representative.

Victoria is a superb site for making movies and television shows, which will promote Victoria to the enormous Indian tourism market.

Meeting Indian business representatives from the Indian film and television industry was a major goal of this trip because the Victorian government would appreciate the chance for investment here.

This would not only create economic benefits for the Victorian film and television industry – with local production staff employed – but also promote Victoria as a top tourist destination for Indians.

I'm glad this trip to India was able to establish those first connections and start conversations about Victoria's attractiveness as a hub for Indian trade and investment.

ASTRALAYA - Australia India Business and Culture Council, a non-profit organisation, was instrumental in setting up important meetings with state government representatives, companies, and the Indian film industry to enhance links between Victoria and India. Through this council, there is a chance to strengthen bilateral culture, and commerce, foster cooperation, and open new commercial prospects between the two nations.

As a result, trade between Victoria and India will be effective in growing the local economy, adding jobs, and attracting investment. Nonetheless, there is always an opportunity for growth in these areas.

## The Trade Relationship Between India and Victoria

1. India is Victoria's second-largest merchandise trading partner, with merchandise exports valued at \$9.1 billion in 2019–20. [1]
2. Trade between India and Victoria is an important element of both countries' economies. Victoria is India's largest trading partner, with two-way merchandise trade reaching \$ 20.6 billion in 2019-20. [2]
3. The Government's dedication to liberalising and diversifying trade with India is the driving force behind this substantial trading partnership. [3]
4. Victoria's exports to India include coal, gold, wine and educational services, while major imports from India include gems and jewellery, pharmaceuticals, apparel and processed foods. [4]
5. Victoria has strengthened bilateral trade, investment, and tourism by establishing solid economic ties with India.
6. Victoria's international education strategy prioritises India as a priority market, and Victoria and India have a growing bilateral connection in the field of education.
7. Victoria has made large investments in India, such as the air freight route between Melbourne and Mumbai.
8. Perishables from India, including seafood, dairy products, fruits, and vegetables, may now be transported to Victoria thanks to this corridor, generating revenue for both nations.

## Summary of Meetings and Visits

### Day 3. Waste to Energy plant – Bowenpally Vegetable Market

The anaerobic system from AES is prefabricated and delivered to the site prepared for operation.

Applications using small – to large-scale feedstocks can use this solution.

Kitchen waste, such as leftover cooked food, fruit and vegetable peels, waste cooking oil and grease, and organic wastewater like ganji (rice water), may all be efficiently digested by the design to produce biogas and bio-fertilizer.

T3 is an effective solution for disposing of organic waste, removing odour, flies, and disposal costs.

It is also a great alternative fuel source. LPG is replaced by biogas, which is stored and used as fuel for cooking.

This highly nutrient-dense liquid fertiliser can be pumped for use in fields, gardens, and landscape areas. The fertiliser is odourless, pathogen-free, and plant-ready.

### Day 3. Meeting with Megha Engineering Infrastructure Limited (MEIL)

MEIL is a diverse industrial conglomerate, established in 1989. It is a rapidly expanding global corporation that has finished numerous iconic projects that reflect historical changes and celebrate economic and cultural progress.

To enhance people's quality of life, it has also constructed numerous significant infrastructure projects around the world. Water management, engineering, construction, manufacturing, transportation, hydrocarbons, power, process industries, and defence are just a few of MEIL's key business segments.

MEIL works to make use of local technological advancements for the benefit of everyone in society.

MEIL is interested in exploring opportunities for its expansion in Australia with its base in Victoria which has the potential to attract large-scale investment and job creation.

#### **Day 4. Meeting with Mr Y S Jaganmohan Reddy, Chief Minister, Andhra Pradesh Government**

A series of discussions were held on synergies that can be created related to energy, education & skills development sectors.

#### **Day 5. Meeting with Telugu Film Producers Council**

**Telugu cinema**, also known as **Tollywood**, is the segment of Indian cinema dedicated to the production of motion pictures in the Telugu language, widely spoken in the states of Andhra Pradesh and Telangana.

Hyderabad's Film Nagar is home to the Telugu film industry. Telugu cinema has the largest box office as of 2021 among Indian film industries. The maximum number of tickets sold for Telugu movies in 2022, totalled 23.3 crores (233 million).

There are opportunities for Victoria to secure the hosting of future major events such as the South Indian Movie Awards – one of the most prominent entertainment awards ceremonies that reward the artistic and technical achievements of the **South Indian film industry** and the **Celebrity Cricket League (CCL)** – inspired by the popularity of the Indian Premier League (official T20 League Tournament of India), with franchises in major Indian cities.

#### **Day 5. Meeting with Gemini Film Circuit**

Gemini Studios was an Indian film studio based in Madras, Tamil Nadu. It was launched when film producer S. S. Vasan bought a film distribution concern at an auction and renamed it.

The new studio opened under the name Gemini. The new facade had statues of 'The Gemini Twins', blowing the bugle.

There are opportunities for their expansion in Victoria which has the potential to attract large-scale investment and job creation.



**Day 5. Meeting with Mr Vijayendra Prasad MP – Rajya Sabha – Parliament of India, Film Screen Writer, Director**

Father of S.S.Rajamouli – Director – RRR- Winner of 95th Academy Award for Original song – “NAATU NAATU” – Telugu song.

His perspective and extensive knowledge of the industry is an amazing resource for understand the opportunities that exist to maximise the potential opportunities in this sector. The need to better align tourism policies with creative arts so that they complement each other is so important.

We should be exploring opportunities for the production and commissioning of scripts that are written about Victoria and reflecting what makes us unique as a more effective way of ensuring engagement and securing local content rather than just filming in a few locations.

Government investment and support at all levels for the sector is a key component.

Zindagi Na Milegi Dobara, scripted with a Spain tourism backing increased tourism by 65% after its release in 2011.

Victoria would also benefit from a visit to Victoria by Mr Vijayendra Prasad to discuss these matters further and explore additional opportunities.

The Temple is constructed using South Indian architecture and is believed to have begun construction in 300 CE.

Victoria is the home for most Malayalees in Australia with a large proportion of them being in the healthcare sector, including as nurses and midwives.

The Minister expressed interest in setting up a Tourism Club to promote tourism and business relationship between Kerala and Victoria.

### **Day 8. Visit to Kerala Legislative Assembly**

The state legislature of Kerala, India, is known as the Kerala Legislative Assembly.

The Legislative Assembly is made up of 140 members who represent constituencies all throughout Kerala.

We undertook a tour of the State Legislature at the behest of Kerala legislators which is an impressive building that is only 25 years old.

### **Day 8. Meeting with Principal Secretaries – Fisheries and Law**

The Department of Fisheries are interested in the establishment of Marine National Parks, dealing with issues of costal erosion, and acquiring equipment to better communicate with their fishing fleets.

They are seeking guidance and the establishment of an information exchange program with Victoria as a jurisdiction who have already successfully established Marine National Parks and has been taking steps to address issues of coastal erosion in some locations around our State.

We also had a discussion to gain an understanding of some aspects of the legal system and framework in Kerala.

### **Day 9. Attended ELECRAMA 2023**

ELECRAMA – the world's largest standalone showcase of electrical and allied electronics equipment and technology. It is organized biennially by the Indian Electrical & Electronics Manufacturers' Association (IEEMA).

IEEMA was founded in 1948 and is the apex association of manufacturers of electrical, industrial electronics and allied equipment in India.

IEEMA's 950+ member companies straddle the complete power value chain in generation, transmission and distribution equipment including cables and wires for buildings and vehicles and new and renewable energy.

During this event we meet with the event organisers and toured the impressive displays from companies attending from around the globe, including Australia.

## **Conclusion**

Strong social and economic ties have existed between Victoria and India for a very long time.

We annually welcome numerous students choosing Victoria for tertiary studies and further education options, with the number of new immigrants who have immigrated from India growing.

After the pandemic, we have faced new difficulties, mainly among them the reported worsening of talent shortages in important sectors including healthcare, tourism, hospitality, and construction.

This gives a chance for a rebound driven by increased productivity and innovation as we manage labour market shifts and methods to rebuild and resuscitate these industries in Victoria.

Additionally, it offers the chance to collaborate with nations like India.

## **Recommendations**

1. Reform and Promote Victoria's policies around economic enhancements for film and television production, to incentivise Victoria as an attractive production destination.
2. Foster closer relationships with the Indian Electrical & Allied electronics Industry to encourage greater trade and investment opportunities in Victoria
3. Ensure State Government agencies have strategies in place to connect and promote Victoria to Indian visitors and investors
4. Further promote Victoria within India, and visa-versa, as desirable tourist destinations. Possible options include State Tourism Clubs.
5. Establish State-to-State information sharing arrangements for the exchange of information about policies and initiatives that have been implemented in respective jurisdictions.
6. Further explore opportunities for Victoria to host significant events like the South Indian Film Awards, Celebrity Big Bash, and other major events in the future.
7. Continue to facilitate Trade delegations and other visits to continue to build on the foundations that have already been established with a view to continually grow and expand in new and emerging areas and sectors.
