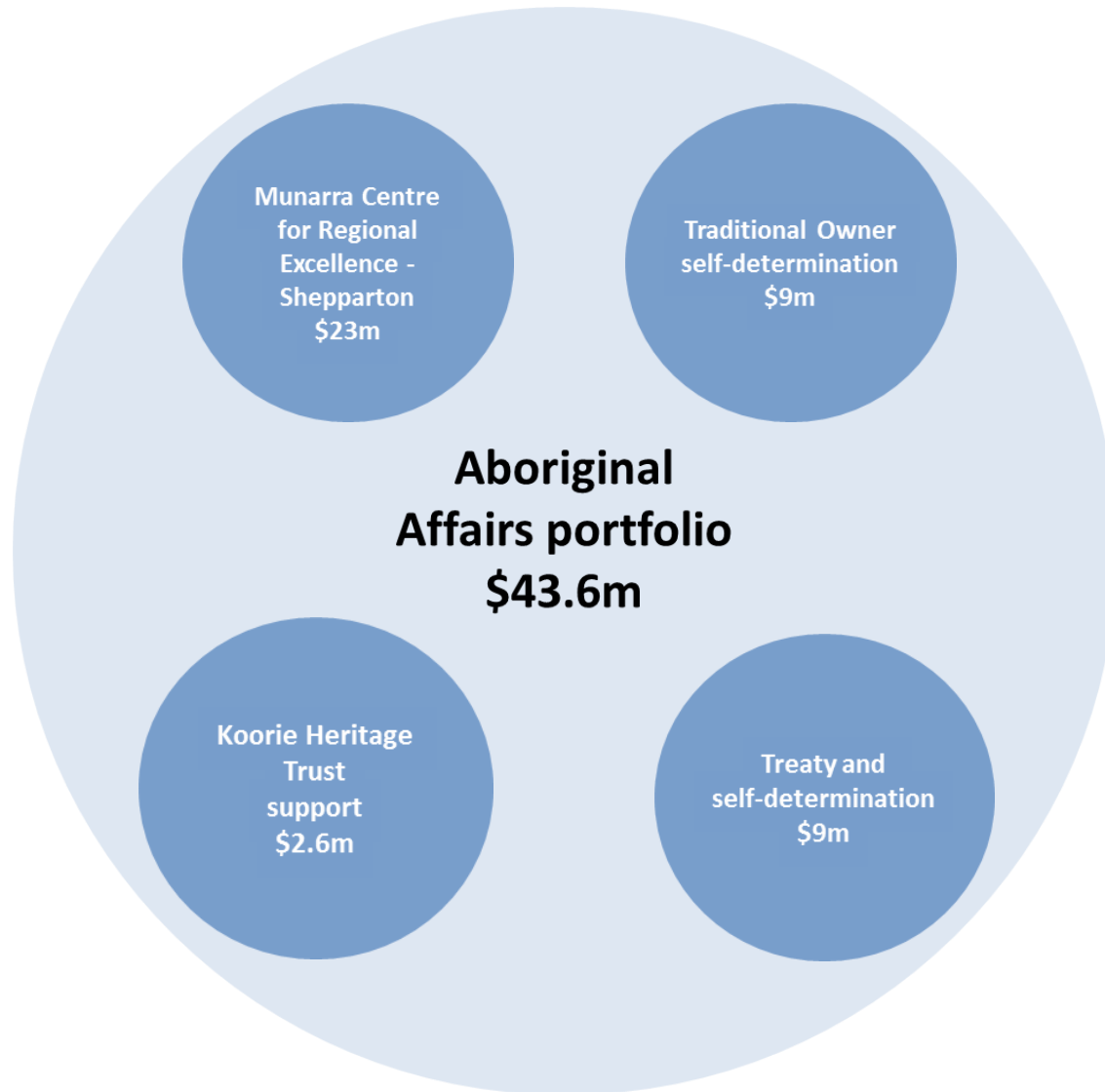

Advancing Treaty



Feb 2016: Self - Determination Forum

To express their longstanding aspirations for Treaty, The Victorian Aboriginal Community calls for Treaty with the Victorian State Government



November 2017: Aboriginal Community Assembly come together

Make recommendations to ATWG relating to governance, representation and structure of the Aboriginal Representative Body



Early 2018: ATWG respond

Provide government with advice on the Aboriginal Community Assembly recommendations



July 2016: Aboriginal Treaty Working Group (ATWG) formed

Terms of reference are to provide options to government on the design of an Aboriginal Representative Body



September to October 2017: Applications for the Aboriginal Community Assembly are open

All Aboriginal people in Victoria are invited to apply through an EOI process



Early 2018: Establish Victorian Treaty Advancement Commission

The establishment of the Victorian Treaty Advancement Commissioner will strengthen independence for the Aboriginal community on the path to Treaty. Its primary role will be to operationalise the outcomes of the Aboriginal Community Assembly and establish the independent Aboriginal Representative Body.



November 2016: Phase 1 of Community consultations

Design principles and roles and functions of the Aboriginal Representative Body created by the Victorian Aboriginal Community



March 2017: Phase 2 of Community consultations including treaty circles

Representation, voting and candidate eligibility and entity structure discussed by the Victorian Aboriginal Community via Treaty Circles, face-to-face consultations and an online message stick



2018 or 2019: Aboriginal Representative Body formed

Aboriginal Representative Body to work with Victorian Government to establish the framework to support future Treaty negotiations
