#### **DTF** comment:

The Government's long-term financial management objectives are provided in annual budget papers in accordance with the *Financial Management Act 1994* (FMA). These objectives are a set of principles that guide the development of State budgets and financial estimates.

Long-term financial management objectives incorporate a wide range of qualitative and quantitative assessments, and cannot be effectively assessed using a narrow selection of metrics. However, the Government does outline the key financial measures and targets it considers important in assessing responsible financial management as part of annual budget papers and budget updates. Recent performance against these measures is addressed in the answers to section H, question 33.

Victoria held a triple-A credit rating with a stable outlook from both major rating agencies for 2015-16. In 2016-17 the State's rating was maintained at 'triple A stable' with Moody's but is on negative watch with Standard and Poors due to the flow on implications of the Commonwealth being on negative watch.
