Treasurer: public sector debt

1611. Mr WELLS to ask the Minister for Finance, WorkCover and the Transport Accident Commission for the Treasurer —

- (1) What additional items, assets and services were purchased in 2007–08 that led to an increase in total public sector debt.
- (2) What additional items, assets and services will be purchased that will lead to an increase in total public sector debt in —
 - (a) 2008–09;
 - (b) 2009–10; and
 - (c) 2010–11.

ANSWER:

I am informed that:

The Shadow Treasurer clearly has difficulty grasping the concept of basic budgeting if he believes, as the question would infer he does, that the Government borrows money against specific projects.

It is concerning not only because he offers himself up as an alternate Treasurer, but the basic nature and structure of the Budget and the Budget Papers makes it clear that this is not the case. Has he read them?

In the 2009-10 Budget, in the midst of a Global Financial Crisis, the Government invested in a Budget strategy which it would appear is working to maintain economic growth at higher than forecast levels in May.

One component of this was to invest \$11.5 billion in infrastructure, in partnership with the Commonwealth, to secure and create 35,000 jobs. A modest increase in borrowings has resulted and our budget remains a Triple A Budget, noting that at Budget Update, net debt to Gross State Product was revised down.

Given the Shadow Treasurer cannot even understand the Budget papers, it is clear he would not have grasped the concepts that has led to this strategy playing a role in boosting our economic forecasts, which he, in his ill-informed way, referred to in his budget reply speech in May, as optimistic in the extreme.

Education: Ferntree Gully electorate

The Office of Housing's Water Saving Project was announced in the Our Environment, Our Future-Sustainability Action Statement 2006, to retrofit water saving showerheads and dual flush cisterns to the balance of public housing stock in Victoria.

As at 30 October 2009, installation of some 8,000 dual flush cisterns and approximately 26,000 water-saving showerheads has been completed across Victoria.

Installations have been carried out across the Office of Housing's property portfolio covering the whole State.

The installations to date have cost \$4.2M. The Victorian Water Trust (VWT) allocated \$4M to the project. The Department of Human Services will ensure the remaining installations are complete and will continue to fund any additional costs above the funding allocated by the VWT to ensure the project is completed

A further 600 dual flush toilets and 13,100 showerheads are expected to be installed, completing the installation phase in mid-2010.

Once completed, this initiative will improve water savings by approximately 2,800 ML per year.

Water: hospital and aged-care water efficiency

In December 2007, the Victorian Government decided that the strategies for the Wimmera and Glenelg Region and the South West Region would be combined into a single Western Region Sustainable Water Strategy. The strategies were combined due to the high level of interaction and similarities between the two regions.

The status for the Western Region Sustainable Water Strategy is:

- a draft strategy is expected to be released for public consultation in early 2010; and
- a final strategy is expected to be released in mid-2010.

The status for the Gippsland Region Sustainable Water Strategy is:

- a draft strategy is expected to be released for public consultation in the first half of 2010; and
- a final strategy is expected to be released in late 2010.

The actual dates for release of the final strategies may vary depending on level of response and issues raised during consultation on the draft strategies. The consultative committees guiding the development of the strategies will consider any feedback on the draft strategies and will be consulted on the time required to adequately consider and incorporate community feedback into the final strategies.

Health: hospital car parking

2670. Mr HODGETT to ask the Minister for Health — do regulations exist for:

- (1) How many car parking spaces must be provided at each hospital.
- (2) How many disabled car parking spaces must be provided at each hospital.
- (3) How many car parking spaces must be provided per bed at each hospital.
- (4) How many disabled car parking spaces must be provided per bed at each hospital.
- (5) How many car parking spaces are designated for patients at each hospital.
- (6) How many car parking spaces are designated for visitors at each hospital.
- (7) How many car parking spaces are designated for staff at each hospital.

ANSWER:

- (1) Yes. The minimum number of car spaces is determined by local Government Planning Schemes. Commonly, 1.3 car spaces are required per bed.

- (2) Yes. These are determined by AS2890.6–2009 which states that for the first 50 car spaces required there must be at least 2 disabled spaces provided, with an additional 1 disabled space provided for every additional 50 car spaces.
- (3) Yes. Refer answer to question (1).
- (4) Yes. Refer answer to question (2)
- (5) No. The number of car spaces required does not distinguish between staff, patients and visitors.
- (6) No. The number of car spaces required does not distinguish between staff, patients and visitors.
- (7) No. The number of car spaces required does not distinguish between staff, patients and visitors.

Health: Maroondah Hospital car parking

2671. Mr HODGETT to ask the Minister for Health — with reference to car parking at Maroondah hospital:

- (1) How many car parking spaces are there.
- (2) How many disabled car parking spaces are there.
- (3) How many car parking spaces are designated for staff.
- (4) How many car parking spaces are designated for patients.
- (5) How many car parking spaces are designated for visitors.
- (6) Are there any current plans to create more car parking spaces.

- (1) 460 spaces are on the site (including 37 spaces immediately opposite the hospital) not including spaces for ambulances, emergency vehicles and patient transport vehicles. This exceeds the requirements of the Maroondah Planning Scheme which requires 424 spaces.
- (2) 14 disabled spaces are on the site plus an additional 3 that are only available for use on weekends. This exceeds the requirements of the Australian Standard which requires a minimum of 11 spaces.
- (3) 380 car spaces are designated for staff.
- (4) 80 car parking spaces are designated for patients.
- (5) Included in the 80 car parking spaces identified above for patients.
- (6) Yes. The Maroondah Hospital Master Plan Review (2006) proposes a 600 car space multi deck immediately opposite the hospital on Grey Street to cater for future demand.

Community services: autism state plan
