- Built on strengths of previous state law
- Strong and robust public protection
- Consistent set of national standards
- Register once, practise nationwide
- Online register 588,000 practitioners nationally
- Student registration
- National workforce data



## Victorian snapshot 2012

- 153,000 practitioners (26% of national total)
- 28,000 Victorian students (31%)
- 58 Victorian education providers (38%)
- 1,674 notifications (21% of national total)
- 10% of Victorian notifications mandatory
- ~ \$30m to local economy from AHPRA national office in Victoria

### Scope and scale

- Bold government vision
- Model unique internationally
- Significant pace and scale of reform
- UK HCPC submission:
  - 10 year bedding-down of UK scheme no complex or high volume professions
  - Significant start up investment required
- Self-funded by registration fees
- Upcoming 3 year national review



## **Roles and responsibilities**

- Straightforward Ministerial oversight/accountability
  - Ministerial Council appoints national Boards and approves registration standards
  - Victorian Minister appoints state Boards
  - Wide accountability Health Practitioner Ombudsman, external tribunals
- National Boards have primary regulatory decision making role
  - Standards, policies and guidelines (national Boards)
  - Registration and notifications about practitioners (state boards and committees)
- AHPRA administers the work of Boards
  - Partnership with Boards
  - State office in Victoria



#### Fees

- Prudent financial management:
  - Fees set by National Boards
  - Single national registration fee for each profession
  - Meet statutory obligations
  - No expectation of additional or ongoing government funding
  - No cross subsidisation between professions
  - Responsible reserves to manage cases and mitigate risk
- Transparency:
  - External audit by VAGO
  - Publish health profession agreements between AHPRA and each National Board
  - Annual Report tabled in each Parliament




### Public safety benefits - notifications

- National notifications system
- National sharing of information
- Flexible law; better for managing notifications and impairment
- Mandatory reporting
- Common purpose AHPRA, National Boards and Health Services Commissioner:
  - Protecting the public and facilitating access to health services

- Notifications:
  - Information to notifiers
  - Strengthen joint consideration with HSC
  - Performance benchmarks/KPIs

- Communication with public and practitioners:
  - Review and strengthen service charter annually
  - Formalise consultation with local consumer groups
