Dr Vivian Waller's submission to the Victorian Parliamentary Inquiry into the Handling of Child Abuse by Religious and other Organisation and her subsequent media comments

I write on behalf of His Eminence Cardinal George Pell, in relation to the submission (**Waller Submission**) that Dr Vivian Waller made to the Inquiry. I **attach** copies of:

- Copies of various comments that Dr Waller made in the media in October 2012 repeating and expanding upon the allegations made in the Waller Submission to the Inquiry (subsequent media comments);
- the media release from this office dated 11 October 2012;
- a letter from Waller Legal to this office dated 12 October 2012;
- a letter from this office to Waller Legal dated 12 October 2012;
- the parts of the transcript (transcript) of the trial of Robert Charles Best (Br Best) which were released by order of the County Court of Victoria on 30 November 2012 following an application made on behalf of His Eminence;
- a schedule comparing the Waller Submission to the Inquiry with the transcript; and
- a schedule comparing the subsequent media comments with the transcript.

It is now apparent that there are significant inconsistencies between the Waller Submission to the Inquiry, Dr Waller's subsequent media comments and the evidence given by Victim 2 in the trial of Br Best. In particular:

- (a) In the Waller Submission to the Inquiry, Dr Waller referred to the fact that Victim 2 was raped by Br Best in 1969 when Victim 2 was in grade 3. Dr Waller then alleges that "subsequently" (page 9 of the Waller Submission to the Inquiry) Victim 2 went to the presbytery at St Alipius and asked to speak to Cardinal Pell but that Cardinal Pell refused to speak to him. Nonetheless, Dr Waller alleges that Cardinal Pell was present when Victim 2 described what had happened to him to another (unnamed) priest. Dr Waller also alleges that Father Ridsdale entered and offered to "deal with it". At page 10 of the Waller Submission to the Inquiry, Dr Waller states that the unnamed priest declined the offer from Father Ridsdale and then made threats against Victim 2. Dr Waller specifically stated (at page 10 of the Waller Submission to the Inquiry) that these threats were made when Victim 2 was still in grade 3. This necessarily meant that the complaint was made during 1969.
- (b) In her interview with Samantha Donovan from the ABC on 11 October 2012, Dr Waller specifically alleged that Victim 2 had been to see Cardinal Pell in 1969. Dr Waller again alleged that Cardinal Pell refused to speak to Victim 2 but that he was present when the allegations against Br Best were made.
- (c) In the media release from this office on 11 October 2012, we confirmed the publicly available information that Cardinal Pell was not in Australia during 1969. In fact, he did not return to Australia until 1971.
- (d) In a letter from Waller Legal to this office dated 12 October 2012, Dr Waller alleged that the Waller Submission to the Inquiry did not claim that Cardinal Pell was in Ballarat in 1969. Dr Waller demanded that this office's media release be retracted and a correction published. However, as noted above, the Waller Submission to the Inquiry did make this allegation and Dr Waller repeated it to the media. Dr Waller did not, at any stage, clarify when she claims the complaint was made by Victim 2.
- (e) The transcript now shows that the evidence of Victim 2 at the trial of Br Best was to the following effect:
  - (i) Victim 2 was raped by Br Best in 1969.
  - (ii) He told a friend about the rape (T66 line 22).
  - (iii) He went to see a priest at the St Alipius presbytery about the incident. This occurred between a couple of weeks and a couple of

- months after the rape (T67 line 18, T134 line 17-18) and "definitely the same year" (ie 1969) (T67 line 9).
- (iv) Victim 2 was unable to identify any of the priests he spoke to other than that one of them had dark, black hair and a deep, strong voice (T67 line 22, T134 lines 21-31) and that this priest was the parish priest at St Alipius Church (T135 lines 1-9).
- (v) Victim 2 tried to tell the priest about the rape but the priest pushed Victim 2 out the door and threatened him (T68 lines 2-8).
- (vi) There was another priest present at the time of Victim 2 made his complaints (who Dr Waller has identified as Father Ridsdale) but Victim 2 did not know his name and Victim 2 could not give a description of this second priest (T135 lines 19-23). The second priest came in "just after [Victim 2] had time to explain to him what happened to [Victim 2]" (T135 lines 11-12). The second priest asked the first priest whether he could deal with it "or something like that" but the first priest said no.
- (vii) The evidence disclosed that there were three priests at St Alipius in 1969: Bishop Mulkearns, Father John Martin and Father Adrian McInerney (T190 lines 16-17). Father Martin had thick, dark hair (T191 line 10, T225 line 22).
- (viii) There is no evidence given by Victim 2 (or anyone else for that matter) of a third priest being present at the time Victim 2 went to the presbytery to make his allegations. Further, there was no evidence of a person matching the description of Cardinal Pell being present at the time and certainly no allegation that Cardinal Pell was actually present. Indeed, Cardinal Pell was never mentioned in the evidence.

In the circumstances, the evidence is unequivocal – that is, when Victim 2 made the complaint at the presbytery in 1969, Cardinal Pell was not present, and that Victim 2 has never claimed that he was. Indeed, no third priest was present and, at the time of the complaint, Cardinal Pell was not in the country. The evidence that Victim 2 gave at the trial of Br Best is entirely consistent with the fact that Cardinal Pell was not in the country at the time that the allegations were made. The allegations which Dr Waller made to the Inquiry and to the media are entirely inconsistent with Victim 2's evidence.

In fact, as set out in the media statement by the Archdiocese of Sydney dated 11 October 2012, Cardinal Pell was never present when any allegations of rape were made by a victim against Brother Best.

Cardinal Pell is committed to ensuring that the truth is told about the extent of sexual abuse in the Catholic Church. It is of some concern that Dr Waller made these false allegations against Cardinal Pell and then failed to retract them when it became apparent to her that they could not have been true (if that was not apparent from the outset). False allegations, such as this, stand in the way of the truth being told and only add to the hurt and suffering of the victims of sexual abuse by making it more difficult to get to that truth.

Indeed, the seriousness of the allegations can be appreciated when it is understood that false accusations such as this are not only seriously defamatory but can (in certain circumstances) amount to a contempt of Parliament and professional misconduct. At the very least, the Inquiry, the media and the public has been seriously misled about Cardinal Pell's involvement in these events.

I hope that this letter assists in correcting the record for the Inquiry.

I have also written to Dr Waller in relation to these matters.

# Cardinal Pell may give evidence at Vic inquiry

Samantha Donovan reported this story on Thursday, October 11, 2012 08:10:00

TONY EASTLEY: It's possible that Australia's most senior Catholic, Cardinal George Pell, will be called to give evidence at the Victorian Parliamentary Inquiry into the Handling of Child Abuse.

In her submission Melbourne lawyer Viv Waller has told the inquiry that in the 1960s George Pell heard a young boy tell another priest he'd been raped by a Christian Brother.

Dr Waller is speaking here with AM's Samantha Donovan.

VIV WALLER: I've been working in this field for a very long time and I'm quite familiar with the fact that a lot of victims of sexual abuse have had difficulty having their complaints dealt with appropriately.

And I'm instructed by one of my clients that in 1969 he went to the local presbytery at Ballarat East attached to a church called St Alipius and he asked to speak to George Pell. And George Pell was there and refused to see him but was present in the room when he was speaking to another priest and he reported that he had been raped by Robert Charles Best who was a Christian Brother working at that school.

Now we are able to discuss that aspect of it freely because Robert Charles Best has subsequently been convicted of raping this client in a criminal trial and he was sentenced for that crime in September 2011.

SAMANTHA DONOVAN: What does your client tell you about how the Catholic Church handled the allegations when he went forward just as a little boy?

VIV WALLER: He was a grade three student and his first attempt to report the rape was actually to his class teacher, another Christian Brother by the name of Brother Fitzgerald. And as he approached his classroom he was in tears and distressed.

And Brother Fitzgerald took him aside and said, "What is wrong with you?" And in very simple playground terms that I can't repeat on radio my client described quite graphically to Brother Fitzgerald what had happened to him, essentially that he had been raped by the headmaster.

And Brother Fitzgerald then beat him, struck him forcibly and then said to him, "Now what happened?" And again my client said that he had been raped by Brother Best. He was struck again and Brother Fitzgerald then said to him, "What happened?" And my client said, "Nothing, nothing happened".

It was after that event that my client approached the local presbytery suffering the delusion that the local priest would be somebody who would assist him in his very distressed state.

SAMANTHA DONOVAN: Do you think it's likely that Cardinal Pell will be called to give

evidence at the Victorian inquiry?

VIV WALLER: I can't make decisions for the committee but it would be reasonable to think that anyone who has written a major submission for the inquiry is likely to be called to give evidence and the Church has put in some substantial submissions.

TONY EASTLEY: Melbourne lawyer Dr Viv Waller speaking with Samantha Donovan. And the Catholic Archdiocese of Sydney has told AM this morning that if Cardinal Pell is asked to appear at the inquiry he will do so as he has stated several times before.

## Probe may call Pell Child abuse inquiry told cover-ups hinder justice

AUSTRALIA'S most powerful Catholic, Cardinal George Pell, was present when a boy raped by a Christian Brother in regional Victoria described to another priest what happened, a parliamentary inquiry has been told.

The Victorian Parliamentary Inquiry into the Handling of Child Abuse by Religious or Other Organisations heard Cardinal Pell was present when the grade 3 student at a Ballarat school in the 1960s described to another priest what had happened to him.

Cardinal Pell may be asked about the incident after indicating in August he would attend the inquiry if asked. The Archdiocese of Sydney's communications office spokeswoman said it could not comment while an inquiry was under way.

Solicitor Dr Vivian Waller, who has represented hundreds of sexual assault victims alleging abuse by religious clergy, outlined the details involving Cardinal Pell in her submission to the inquiry.

In another scathing submission, police accused church leaders of persuading sex abuse victims to stay silent and tipping off offenders to destroy evidence.

And the Catholic Church has proposed it selectively reports details of allegations to police without identifying alleged victims.

Victoria Police accused the church of failing to help authorities tackling child sex crimes and called for new laws against concealing an indictable offence.

The Catholic submission called for a coronial inquiry into the number of victims of sexual abuse who have committed suicide.

It also defended the right for allegations made in the confessional to stay confidential, suggesting priests report serious allegations, but only if they held back identifying information.

"Regarding reporting to the police, the Church has found that many victims want their experiences to remain private and do not want their complaint reported," the submission reads.

Other churches such as the Anglican Diocese of Melbourne rejected mandatory reporting, opting for experienced clergy to hear the confession of offenders and withhold absolution of sins until the confessor reported to authorities.

Police claimed in their submission the Catholic Church bribed victims to keep quiet about their allegations and shifted alleged offenders to different parishes to hinder police investigations.

"It is the opinion of Victoria Police that such deliberate action should be criminalised," it stated.

### Police slam Catholic Church

VICTORIA Police has launched a scathing attack on the Catholic Church, accusing it of deliberately impeding its investigations into child abuse.

In a submission to the parliamentary inquiry into the handling of child abuse by churches, signed by Chief Commissioner Ken Lay, police recommend that some of the church's actions to hinder investigations be criminalised.

The submission lists a number of ways in which the church has hindered the criminal justice process, including dissuading victims of sexual crimes from reporting them to police, failing to engage with police and alerting suspects of allegations against them, "which may have resulted in loss of evidence".

It says the church moved or protected known or suspected sexual offenders. While the submission notes the church has recently improved co-operation with police, in some cases it has been reluctant to provide information even when a warrant was issued.

Police also say the typical delay in reports of sex offences within the church means more reports of alleged offences from the 1990s and early 2000s are expected in coming years.

Another submission, by lawyer Vivian Waller, who has represented more than 70 abuse victims, says that now-Cardinal George Pell refused to listen to a boy who was raped in Ballarat in 1969 soon after the event. But Father Pell was in the room when the victim told another priest what happened. Both times the victim tried to tell his story he was badly beaten, though not by the now Archbishop of Sydney, the submission says.

The inquiry into the handling of abuse by religious and other organisations was established in April after years of campaigning by victims, advocates and media, and particularly after a series of articles in *The Age* revealing the extent of abuse within the church and the mishandling of allegations by church-appointed officials.

Confidential police reports detail the suicides of at least 40 people sexually abused by Catholic clergy in Victoria and say it appeared the church knew about a shockingly high rate of suicides and premature deaths but had "chosen to remain silent". The Age also reported earlier this month that a senior police investigator had told victims of a suspected Catholic paedophile of his "grave" concerns that his investigation into their alleged abuser was being derailed and that "pro-church police members" might have interfered in his inquiry.

The Catholic Church has consistently acknowledged past mistakes but maintains it has improved its protocols for dealing with victims since 1996, when it established its national Towards Healing internal inquiry process.

But police, in their submission, are particularly critical of this and the Melbourne archdiocese's equivalent process, the Melbourne Response, in which victims may not be legally represented, saying it appeared to be a "de facto substitute for criminal justice" and detrimental to prosecuting suspected sexual criminals.

The Melbourne Response states on its website that in the past 14 years the church has compensated 300 people as victims of sexual abuse and identified 86 offenders, of whom 60 were priests. Yet not one complainant was referred to Victoria Police, the submission says.

"Some of the offenders may be laicised, however this is rare. In many cases offenders are moved to other positions within the church which have a limited opportunity for offending, or provided with counselling," police say.

"The inquiry process restricts the ability of victims to have the offender brought to account through the criminal justice system, and promotes the culture of secrecy which prevents more victims speaking out."

Police say the system's independent commissioner and assessors are not trained or resourced to deal with the allegations and do not have the benefit of recent changes to the way in which police typically interview victims of sexual assault to reduce trauma.

"Indeed, we are aware of circumstances where victims have been required to confront alleged offenders where they have been required to repeat allegations in the presence of these alleged offenders," police say.

"Victoria Police has offered to provide this briefing to the Catholic Church on two occasions but these offers have not been accepted to date."

In its submission to the inquiry, the church says it has removed its opposition to mandatory reporting of clergy and church workers suspected of abusing children - apart from the sanctity of the confessional.

It says it would support reporting all allegations if police guaranteed to respect the victim's right to privacy.

Justice Philip Cummins proposed extending mandatory reporting in his report of the Protecting Victoria's Vulnerable Children inquiry, and Melbourne Archbishop Denis Hart said in a statement yesterday that clergy should operate under the same rules as doctors, nurses, teachers and police.

He said all serious crimes should be reported to police but that there was a tension between calls to report all abuse allegations and the wish of some victims to keep their experiences private and unreported to police.

A system should be set up in which all details except those that identify the victim are reported to police, on the basis that police powers of compulsion are not used to discover the victim's identity, the church says.

The submission, from Victoria's four diocesan bishops, acknowledges that the church was slow to believe victims, underestimated the often devastating harm, took too long to respond effectively, believed offenders' denials or that they could be cured and at first favoured a legal response rather than a pastoral one.

The independent commissioner for the Melbourne Response, Peter O'Callaghan, QC, told *The Age* last night: "I will respond to the police submission by providing written submissions to the parliamentary committee. It is therefore inappropriate to make comment, save to say that there is much in the police submission which is seriously misconceived and quite wrong and which I will correct and refute in my submission to the committee."

Church spokesman Father Shane Mackinlay said: "We are reviewing the police submission and many others. Facing The Truth [the church's response to the inquiry] addresses many of the matters raised by the police."

## Cardinal Pell denies hearing rape claim

#### **CLERGY ABUSE**

CLAIMS that Cardinal George Pell was present when a boy described being raped by a Christian Brother in Ballarat in 1969 were "irresponsible, untrue and are absolutely denied", the cardinal said yesterday.

Now Archbishop of Sydney, he said he was not in Ballarat in 1969 when the boy was raped and was not appointed to the diocese until 1973.

The allegations were in a submission by Melbourne lawyer Vivian Waller, who is acting for more than 70 victims of abuse by Christian Brothers, to the parliamentary inquiry into how churches handled child abuse.

Dr Waller said the boy came back to class at St Alipius distressed after the rape and was beaten by another Christian Brother until he retracted the claim.

Later, it is claimed the victim asked to speak to Father Pell, who refused to see him but was allegedly present when he told a second priest.

A third priest took him and beat him again, the submission says.

Cardinal Pell, who said he would be happy to give evidence at the inquiry, said the error had been repeated by media throughout the country.

But Dr Waller replied last night that she had not given a date when the victim told the priest his story, merely saying "subsequently", and she stood by the submission.

# Pell denies being present when rape claims made

Claims that Cardinal George Pell was present when a boy described being raped by a Christian Brother were "irresponsible, untrue and are absolutely denied", the cardinal said yesterday afternoon.

The allegations by Melbourne lawyer Vivian Waller, who is acting for more than 70 victims of abuse by Christian Brothers, were widely reported yesterday.

Dr Waller said in a submission to the Victorian parliamentary inquiry into how churches handled sex abuse that Brother Robert Best raped the boy at St Alipius school in Ballarat.

She said the boy went back to class distressed and was beaten by his teacher until he withdrew the claim.

Later, believing a priest could help him, the boy had asked to speak to the then Father Pell, who had refused to see him, but Father Pell had been present when the victim told another priest what happened, it is claimed.


According to the submission, a third priest, notorious paedophile Gerald Ridsdale, then entered and offered to "deal with the situation", which he did by again beating the victim.

Yesterday Cardinal Pell, now Archbishop of Sydney, said he had not been in Ballarat in 1969, which is when Dr Waller said the rape occurred, and was not appointed to that diocese until 1973. Unfortunately, the error had been repeated by media outlets across the country, he said in a statement from the Archdiocese of Sydney.

Indicating he would be happy to give evidence to the inquiry, he said he was never present when any allegations of rape were made by a victim against Brother Best.

"The truth will avoid further hurt to victims. Unsubstantiated allegations and personal and false smears are of no assistance to victims or to the inquiry."

Cardinal Pell said he hoped parliamentary privilege enjoyed by those involved would not be "exploited with calumny".

#### MEDIA STATEMENT BY THE ARCHDIOCESE OF SYDNEY

As Archbishop of Sydney, Cardinal Pell does not usually comment on religious life in Victoria and does not plan to comment on the activities of the Victorian Parliamentary Inquiry into the Handling of Alleged Criminal Abuse of Children by Religious and Other Organisations. It is however necessary to respond to recent reports about a false and seriously misleading allegation contained in a submission to the Inquiry.

The claims made in relation to Cardinal Pell in a submission to the Inquiry by Waller Legal are irresponsible, untrue and are absolutely rejected.

Unfortunately, factual errors in the submission to the Inquiry made by Dr Waller of Waller Legal, relating to Cardinal Pell's presence in the Diocese of Ballarat in 1969, have been repeated by media outlets across the country.

These are the facts. The Cardinal was ordained a priest in 1966 in Rome, he continued his studies and then travelled to Oxford to study for his Doctorate. Cardinal Pell was studying at Oxford in 1969 and was not a priest appointed in the Diocese of Ballarat at the time alleged in Dr Waller's submission. Cardinal Pell returned to Australia in 1971 and worked at Swan Hill in the Diocese of Ballarat. In 1973 he received his second appointment as a priest in East Ballarat.

In any event, Cardinal Pell was never present when any allegations of rape were made by a victim against Brother Best.

Cardinal Pell's postings from the early 1960s are well documented and could have easily been checked by Dr Waller (which may well have been of assistance to her client, Victim 2). These details could also have been easily checked by the media outlets reporting on the Inquiry. Factually incorrect submissions may well distract and mislead the Inquiry in the important work it is undertaking.

Cardinal Pell said that the truth will avoid further hurt to victims. Unsubstantiated allegations and personal and false smears are of no assistance to victims or to the Inquiry. He is hopeful that the Inquiry will be able to continue its important work and not have its processes and the Parliamentary privilege afforded to all involved exploited with calumny.

During his sixteen years as Archbishop of Melbourne and Sydney, Cardinal Pell has regularly explained to the public the procedures followed by him in the areas of his responsibility, his Archdioceses, to combat sex abuse and has never distanced himself from his responsibilities.

Cardinal Pell welcomes efforts to provide healing for victims and to discover the truth. He has previously indicated that if the Victorian Inquiry feels it would be helpful for him to give evidence, he would certainly do so.

Media Release of the Archdiocese of Sydney dated 11 October 2012 in Relation to the Parliamentary Submission Made by Dr Waller of Waller Legal

We refer to your letter of today's date and your submission to the Victorian Parliamentary Inquiry.

With respect, it is difficult to reconcile your letter with the content of your submission and the comments that you made to the media yesterday.

A fair reading and, in light of your media comments referred to below, the clearly intended reading of your submission suggests that the person you refer to as "Victim 2" attended the St Alpuis' presbytery in 1969 and asked to speak to Cardinal Pell.

Page 9 of your submission sets out a circumstance whereby Victim 2 is said to have attended the St Alipius' presbytery after being struck by Br Fitzgerald. Page 13 of your submission makes the temporal connection quite clear. That reads:

For the sake of clarity, let's recap the chronology. Victim 2 was brutally raped in 1969. Victim 2 reported the rape to another Christian Brother on the day it occurred and was violently and repeatedly beaten until he retracted his complaint. He reported the rape to 3 priests in the diocese of Ballarat thereafter and was beaten and his life threatened if he told anyone.

The ordinary reading of pages 9 and 13 of your submission suggests that your assertion to the Victorian Parliamentary Inquiry is that the incident involving the alleged report to Cardinal Pell occurred in 1969 in a circumstance that is temporally connected to the rape of Victim 2 and the stated reporting to Br Fitzgerald.

Not only is that a fair reading of your submission, but in light of your comments in the media it appears to be an accurate indication of the instructions from Victim 2, upon which you drafted your submissions.

In your interview with Samantha Donovan, reported on ABC AM yesterday (available as both a recording and a transcript at <a href="http://www.abc.net.au/am/content/2012/s3608277.htm">http://www.abc.net.au/am/content/2012/s3608277.htm</a>) you stated:

... And I'm instructed by one of my clients that in 1969 he went to the local presbytery at Ballarat East attached to a church called St Alipius and he asked to speak to George Pell. And George Pell was there and refused to see him but was present in the room when he was speaking to another priest and he reported that he had been raped by Robert Charles Best who was a Christian Brother working at that school.

The fact is that Cardinal Pell was not present at St Alipius' in 1969. He was not present in the Diocese of Ballarat until 1971. He was not at St Alipius' until 1973.

If you now contend that your submission (particularly when considered against the background of your public comments regarding the instructions upon which you drafted your submission) is intended to mean something different than the plain reading of your submission would suggest, then we consider it important that you amend your submission to the Parliamentary Inquiry and make the appropriate public corrections.

We would be grateful if you would provide us with a copy of any amended submission.
