MY D.O.B IS 57 AND I KNOW I WAS MINNEY YEARS OLD WHEN PLACED IN THAT HORRENDOUS ORPHANAGE. THE NEXT SCHOOL ATTENDED WAS STLIBORIUS PRIMARY WHICH I WAS ENROLLED FOR THE START OF 1968. P.S I HAVE CONFIRMATION ON PAPER FROM ST LIBORIUS. MY BROTHER PAUL, SISTER SYSAN AND I WERE PLACED IN ST. AIDANS WHERE OUR FAMILIES WERE TOLD WE WOULD BE WELL TAKEN CARE OF. IF ONLY THEY KNEW WHAT WENT ON BEHIND CLOSED

WHEN TAKEN THERE BY OUR FATHER FRED (DECEASED) WE WERE GREETED WITH LOVELY SMILES AND PROMISES OF HAPPINESS AND GUARANTEED OUR FATHER WE WOULD BE O.K. AND THAT HE WOULD HAVE NOTHING TO WORRY ABOUT. LIE NO I AND THERE ARE PLENTY MORE.

ONCE THE FRONT DOOR WAS CLOSED IT BECAME A NIGHT MARE. SLISAN TAKEN TO ANOTHER BUILDING AND MY BROTHER PAUL AND I SMACKED ACROSS THE EARS AND TOLD TO FOLLOW ANOTHER NUN. WE WERE TAKEN TO THE DORMATORY WHICH MUST HAVE AT LEAST 40 OTHER BOYS. WE WERE SHOWN OUR BEDS WHICH WERE SIDE BY SIDE AND TOLD SOME RULES () NO TAKING!!

(2) NO WETTING THE BEDS!! (3) NO GETTING UP TO GO TO THE TOILET!! IF YOU WET THE BED YOU HAD TO SLEEP IN IT AND TO-MORROW AS ILEI!!! WE IL.

BEFORE SCHOOL THE BOYS HAD TO HAVE THEIR HEADS BOWED WHILE THE GIRLS ENTERED CLASS ROOMS. ON MORE THAN ONE OCCASSION / WOULD SPOT MY SISTER SUSAN AND MOVE MY FINGERS TO SAY HELLO, EVERY TIME I WAS CAUGHT I WOULD GET THE CUTS" FROM A NUN WITH A STEELE RULER. IF I MOVED IT WAS DOUBLE THE PAIN. SHE WOULD SMILE IF YOU CRIED OR HAD BLOOD COMING FROM YOUR KNUCKLES. 1 STILL REMBER HER NAME AND WHEN / WAS WORKING AT A SUPERMARKET STORE IN BENDIGO I SAW HER AND SAID HELLO MOTHER SHE ASKED "HOW DO I KNOW YOU?" "I WENT TO STAIDANS ORPHANAGE I REPLIED SHE ASKED ME MY SURNAME AND WHEN ! TOLD HER SHE SMILED AND SAID" THAT'S RIGHT THERE WERE THREE OF YOU WASN'T THERE YOU, A BROTHER AND A SISTER SUSAN 17 WAS THE SAME SMILE SHE WOULD GIVE WHEN I WAS CRYING OR HAD BLOOD COMING FROM MY HANDS. SHE DID THAT AND COULD NOT REMEMBER MY NAME BUT 1 REMEMBERED HERS AFTER SOME 20YRS OR SO. HOW I WANTED TO PUNCH HER OR GIVE HER A PEICE OF MY MIND BUT SOMEHOW MANAGED TO CONTROL MYSELF, WALK AWAY AND START CRYING IN THE MANAGERS OFFICE. MY BROTHER AND I HAD PERFORATED EAR DRUMS WHILST IN THE ORPHANAGE. PERHAPS IT WAS CAUSED BY SMACKED ACROSS THE FACE BY NUNS.

WE HAD SURGERY WAS BENDIGO HOSPITAL AND WERE TREATED LIKE LITTLE PRINCES COMPARED TO WHAT ST ADDANS GAYE YOU. UNFORTUNATELY WE HAD TO GO

THE EARS WERE CUT FROM BEHIND AND THEN STITCHED BACK. SO, HERE WE ARE BACK IN HELL WITH STITCHES STILL IN OUR EARS WHEN ONE DAY MOTHER FOR SOME REASON STARTED PULLING PAULS EAR AND ALL YOU COULD HEAR WAS SCREAMING AND BLOOD ALL OVER PAUL. SHE WAS SMILING AGAIN BY NOW. THAT CRUEL BITCH! HE WAS ONLY ABOUT TROOLDA WHEN THE BOYS GOT TO A CERTAIN AGE THEY HAD TO LEAVE, WHETHER IT BE ANOTHER ORPHANAGE OR ADOPTION 1 THINK THE CATHOLIC CHURCH THOUGHT MALES WERE BEGINNING TO LIKE FEMALES. WE WERE NOT EVEN ALLOWED TO LOOK AT OR TO FEMALES.

EVEN DUR OWN SISTER!" HELLO ARE YOU LISTENING! PAUL WENT TO LIVE OUR UNCLE AND AUNTIE

A... BEFORE LEFT HE + 1 HAD TWO MAIN JOBS.

NE HAD TO CLOSE THE CAST IRON ENTRANCE AT NIGHT AND OPEN THEM IN THE MORNING.

THERE WERE PROWLERS BECAUSE OF THE FEMALES, AND ONE PARTICULAR NIGHT WE WERE WALKING TO CLOSE THE ENTRANCE WHEN THERE WAS A NOISE ON THE SIDE FENCE WE WERE TERRIFIED AND RAW BACK INSIDE WITHOUT CLOSING THE ENTRANCE.

THE NEXT MORNING WE GOT THE CUTS FOR NOT DOING IT OUR SECOND JOB WAS TO TAKE EGGS & BUTTER TO "THE POOR CLAIRE SISTERS" IN

EDWARDS RD WHICH WAS JUST A 5 MIN WALK IF WE WERE NOT BACK WITHIN 10 MINS IT WAS THE CUTS. YOU GLIESSED IT WE GOT THEM PLENTY OF TIMES

PAUL AND I COULD HAVE WALKED OUT THE GATE PLENTY OF TIMES BUT WHEN YOU ARE AS YOUNG AS WERE WHERE DO YOU GO! WE KHEW THEY WOULD FIND US SOONER OR LATER IF WE DID AND THE PUNISHMENT UNTHINKABLE, OR UNBEARABLE!!! NOW THE DAY HAD COME FOR PAUL. WAS CRYING TEARS OF HAPPINESS AND SADNESS SO HAPPY FOR PAUL AS HE WAS NOW MOVING ON TO START A NEW LIFE FROM THE HELL HOLE HE WAS IN. OUR GRANDPARENTS & FATHER WOULD ALWAYS GIVE US NEW AND CLOTHES AND A LARGE BAG OF LOLLIES AND TOYS EACH.
WHEN ARRIVING BACK THE NUNS WOULD SAY LOVELY CHILDREN WE WERE AND THERE WAS STILL NOTHING TO WORRY ABOUT.

THEN THE DOOR WOULD LOCK. EVERYTHING GIVEN TO US

AFTER US BARRACKED FOR HAWTHORN.



HA! HA!



WITH THAT SHE GRABBED ME BY THE BACK OF THE HAIR AND SHOVELLED IT IN MY MOUTH WITH A SPIN. BUT SHE WAS NOT FINISHED WITH ME YET. AS I SAID WE HAD TO CALL HER MISS AND BECAUSE I DION'T IT WAS "CUTS" TIME AGAIN WITH THE RULER HANDS STRAIGHT OUT FACING UPWARDS AND I'M PREPARING MYSELF FOR SIX "CUTS" BUT I MOVED MY HANDS SO GOT 12. AS I MENTIONED THE BOY I HAD TO LOOK AFTER DIRTIED HIS YNDER PANTS ETC SO MUCH 1 14AD TO WASH THEM IN A BUCKET WHILE EYERYONE ELSE PLAYED AROUND ME I AM ASHAMED ABOUT ONCE I PUT HIM IN THE BATH AND USED DHLY HOT WATER. WHEN SOME-ONE HEARD HIS SCREAMS GOT HIM OUT AND PLACED ME IN IT TO SEE HOW / LIKED IT. I'M SO SORRY BUT I WAS ONLY JOR 8 YRS OLD. TO THIS VERY DAY I CANNOT REMEMBER ANY OTHER BOY WITH THE RESPONSIBILITY LIKE THAT. ONE DAY I WAS CAUGHT TALKING TO A MAINTENANCE MAN. MRK PARKER WHO I KNEW BECAUSE HE USED TO BE A FREIND OF MY UNCLES. 1 SHOULD NOT HAVE DONE THAT SO I GOT PUNISHED HERE IS ANOTHER LIE. SOMETIMES THEY WOULD TELL US THAT OUR DAD OR GRANDFATHER WERE TAKING US OUT FOR THE DAY. THEY WOULD DRESS US UP NEATEY AND TELL 48 TO WAIT ON THE SECOND FLOOR BALCONY. THERE WE WAITED IN ANTICIPATION FOR OUR GRAND FATHERS 1964 HOLDEN WAGON TO ARRIVE. I HAVE A LONG MEMORY SO CAN TELL YOU THE REGO NO. N.S.W. D.G.Z. 543. THAT CAR DID NOT COME SOME DAYS AND THEY KNEW IT WAS NOT GOING TO. JUST ANOTHER WAY TO MAKE LIFE MISERABLE. WE WERE SO BRAIN WASHED ABOUT THE CATHOLIC RELIGION AND CHURCH. WHEN I DID MY CONFIRMATION 1 WAS GIVEN A SILVER CRUCIFIX BY A MRCARPENTER WHO WAS ALSO A MAINTENANCE WORKER. HOW I CHERISHED THAT CRUCIFIX.

A LITTLE WHILE LATER IT WAS NOW MY TURN TO LEAVE. I DID NOT KNOW WHERE I WAS GOING BUT THANKFULLY THE TWO MOST BEAUTIFAL, LOXING CARING PEOPLE TOOK ME HOME. MY GRANDPARENTS. WITH THAT HE HIT ME WITH AN OPEN HAND AND SAID FOR THAT SMART REMARK YOU WILL NOT BE SERVING AT CHURCH TO DAY" I REPLIED "WELL FOR THAT I AM NOT COMING BACK TO YOUR CHURCH AGAIN" SO I Took OFF MY ALTAR BOYS UNIFORM AND WENT HOME. NOW I ONLY GO TO CHURCH FOR WEDDINGS 1 NO LONGER HAVE ANY FAITH. WHEN PRIMARY SCHOOL FINISHED / ATTENDED EAGLEHAWK HIGH. I FOUND IT VERY HARD TO TALK TO FEMALES AND STILL DO. 1 THINK IT 15 BECAUSE WE WERE NOT ALLOWED TO AT ST AIDANS
