Dear Ms Howe

I refer to your letter of 4 January 2010 addressed to the Minister for Health in which you raised issues concerning missing medical records and your experiences with both St Joseph's and the Royal Women's Hospital at the time of your 1963 pregnancy. Your letter indicated that records connected to social workers at Royal Women's Hospital were destroyed and requested that the Minister find out who was responsible for destroying those records.

The Minister has requested that I respond to your letter on his behalf.

The department has made enquiries about records referred to in your allegations, however due to the length of time since those events it has not been possible to determine what notes or other records (other than medical records you have already discussed with the Royal Women's Hospital) were maintained by hospital social workers. Nor has it been possible to determine what might have happened to any records that may have been maintained by social workers.

For these reasons the department is unable to assist with your request and I do not consider there is anything to be gained by pursuing the issue of missing records any further.

Should you wish to pursue other matters referred to in your letter, as the Minister indicated to you in his letter of 24 December 2009, you should seek your own independent legal advice.
