# Context

- Responsible decisions in a challenging fiscal environment
- Concern over Commonwealth funding and decisions
- Committed to maintaining our AAA credit rating

2013-14 Budget will provide \$14.3 billion spending in health and ageing services

# **Responsible Management**

- Victorian hospitals are efficient Lowest cost per separation in Australia
- This means Victoria's health dollar goes further
- Investing in continued innovation and improvement to enable
  - service quality improvements
  - further efficiencies to ensure every possible dollar is directed to improving Victorian's health

#### 2013-14 Health Budget Highlights

\$14.3 billion on health and hospital services

 \$661 million increase for health services in 2013/14 (\$2 billion increase since coming to government)

\$629 million TEI capital projects

#### Hospital services – Acute Health Services

- \$504 million increase in 2013-14 (\$1.45 billion since coming to government)
- \$282.6 million to secure Victoria's health system (\$1.2 billion over 4 years)
  - \$176 million to treat more patients (\$751.3 million over four years)
  - \$101 million for elective surgery (\$421 million over four years)
  - \$5 million for organ transplants (\$20.8 million over four years)
- \$26.6 million over four years to improve the quality of health services and deliver better patient outcomes

# Health Workforce

- \$238.3 million over four years to train the future health workforce
- \$194 million for clinical placements days for undergraduate students
  - 45% increase in funding compared to the previous government
  - 200,000 additional training days
- \$42 million for postgraduate positions
  - 860 additional doctors and nurses in training
- \$3 million to train an additional 24 rural generalists.

# Community Health

- \$24.9 million increases for community health services in 2013-14 including:
  - \$62 million to improve health outcomes for Aboriginal Victorians over four years
  - \$22 million for health services to support refugees and asylum seekers
  - \$12.5 million to boost community health services
- \$9.7 million for Western Region Community Health and \$18.2 million for Health Precincts and Community Ambulatory Care Centre

# **Ambulance Services**

- 17.2% increase in ambulance funding since coming to government (\$98.2 million)
- Inherited a Ambulance Service in Crisis
- \$151 million to increase ambulance officers by 340
  - 210 rural paramedics, 100 metropolitan paramedics and 30 patient transfer officers
- 97% of community satisfied with the performance of Ambulance Victoria
- Top 4% of Ambulance Services in the world
- Cardiac outcomes have improved.



- Victorian Health Priorities Framework 2012-22 outlines challenges facing the health system and provides for a planned response
  - Demand pressures include: Population growth,
     Ageing population High utilisation rates
- Commonwealth uncertainties and decisions


# **Commonwealth Impacts**

- Commonwealth retrospective funding cut
  - \$107m cut during mid way through 2012-13 year
  - Promise to restore was slow to be fulfilled, still feeling the ramifications
  - The full cut remains through the forward estimates (\$368m to 2015-16).

#### Lapsing Commonwealth NPAs

- Lack of determination by Commonwealth regarding expiring NPAs
- Hospital and health workforce reform
- Closing the Gap in Indigenous Health Outcomes no word yet on if the Commonwealth will match Victoria's commitment

Victorian Cytology Service Implementation Plan (Health Services NPA)	\$30.1 million over 4 years	30 June 2013
National Perinatal Depression Initiative (Health Services NPA)	\$5.8 million over 3 years	30 June 2013
Vaccine Preventable Diseases Surveillance Program (Health Services NPA)	\$0.6 million over 3 years	30 June 2013
NPA on Improving Public Hospital Services	\$723.1 million over 5 years ( <i>excluding</i> \$99.2 million in potential reward funding)	30 June 2014 (facilitation and project funding ends, potential reward funding available until 2016-17)

# **Commonwealth Impacts**


- Carbon Tax impost \$6.7 million for first six months of 2013/14
- Other risks from Commonwealth action
  - Funding uncertainty esp. for IPHS
  - Health 'deal' implementation costs, burdens, bodies
  - Private Health insurance cuts




- Commonwealth share of funding for public hospital services has been decreasing

2008-09








# **Planned Response**
