INTRODUCTION

The parliamentary inquiry into Victoria's COVID-19 contact tracing and testing regime has begun taking evidence.

This is a chance for your voice and experience with Victoria's contact tracing system to be shared and heard to ensure we have the best possible COVID-19 system so we can all stay COVID safe in the months ahead.

Submissions can be made via an online form available at parliament.vic.gov.au/contacttracinginquiry.

Submissions need to focus on COVID-19 contact tracing and testing. Hearings will be conducted by the Legislative Council Legal and Social Issues Committee. These will be held from 16 November.

FAQS

What is a parliamentary inquiry?

The main purpose of a parliamentary inquiry is to investigate a particular topic. Parliamentary committees are made up of Members of Parliament from different political parties. They report their findings and recommendations to the Parliament. As part of an inquiry, a committee seeks the views of those who may have an interest in the topic of the inquiry.

Who can make a submission?

Any individual or organisation can make a submission to a parliamentary committee.

What should be in a submission?

There is no set format for a submission to a parliamentary committee. Submissions may be in the form of a letter, a short document or a more substantial paper, or in audio visual format. They may include appendices and other supporting documents.

Submissions should be prepared solely for the inquiry and should not have been previously published. They should comment on at least one of the terms of reference. You may wish to include facts, opinions and arguments and recommendations for action.

What happens after I make a submission?


An email confirming your submission will be sent to you. If the submission is approved by the Committee, it will be published on the website.






Have your say:
