Inquiry into Locally Based Approaches to Community Safety and Crime Prevention: Victorian Government Response

On 10 February 2011, the Drugs and Crime Prevention Committee received terms of reference from the Legislative Council that requested it inquire into, consider and report on locally based approaches to community safety and crime prevention.

In particular, the Committee was asked to consider:

- the breadth of locally based groups and organisations addressing community safety and crime prevention issues within Victoria, particularly with regard to local government and Neighbourhood Watch;
- the approaches adopted by these groups to promulgating community safety and crime prevention practices, programs or initiatives;
- the extent to which these organisations are effective in engaging with local and state agencies in the development of policy;
- whether institutional or other arrangements support or impede such local groups in engaging in the development of community safety initiatives;
- whether there is a cost benefit to the community for current crime prevention strategies;
- · whether alternate models for such organisations may improve outcomes; and
- local community safety and crime prevention arrangements in other jurisdictions, particularly within Australia, New Zealand and the United Kingdom.

The Victorian Government response to each recommendation is as follows:

- Support: The Government supports the recommendation and is currently enacting or will soon enact initiatives or activities that are in line with the recommendation
- **Support in principle**: The Government supports the theme of the recommendation but will achieve the outcomes in a different manner to that suggested by the Committee. Alternatively, there may also be funding implications that the government has yet to consider, or support may be contingent on the outcome of another process
- Support in part: The Government supports one or more aspects of the recommendation, but does not support another aspect
- Not supported: The Government does not support the recommendation
- Recommendation noted: The recommendation is not directed to the Victorian Government.

Recommendations

On 5 June 2012, the Final Report was tabled in Parliament with a number of recommendations made:

The Government supports councils actively working with their local communities and Victoria Police to identify and respond to local community safety and crime prevention issues and priorities. 		Mandating reporting requirements in legislation may not always support the uptake by local governments of best practice in planning crime prevention and community safety strategies. Further it may not accommodate the wide range of circumstances and contexts faced by Victoria's 79 local governments, resulting in a focus upon compliance, at the cost of innovation and the uptake of best practice.

The Committee therefore recommends that there is a need for the Community Crime Prevention Unit to ensure state-wide evidence based research, access to evaluation of programs and best practice modelling is provided or made available to councils in order to deliver effective crime prevention and community safety programs.	Support	The Government supports continuing to develop the evidence base to help build community capability to deliver effective crime prevention initiatives. The Government will support councils and local communities by providing information to build greater knowledge and understanding about effective crime prevention initiatives, within current available resources.

Such an evaluation would assess their effectiveness in achieving desired outcomes and identify the practical challenges and lessons for implementing similar projects.	Support in principle	The Government notes each of the grant programs under its Community Crime Prevention Program has evaluation mechanisms built in, commensurate with the level of the grant funding. In some grant programs, this includes an independent evaluation requirement. Any additional evaluation activity would be subject to Government consideration through the normal state budget process.
24. The Committee recommends that the Victorian Government establish an independent crime research, statistics and data collection/analysis agency to assist local government, police and community agencies with the provision of data and evidence to inform the development and implementation of crime prevention programs and initiatives. The Bureau of Crime Statistics and Research (BOCSAR) in New South Wales may serve as a useful example.	Support in principle	The Government notes that the Committee's recommendation aligns with a recommendation made by the Ombudsman in his 2011 report Investigation into an allegation about Victoria Police crime statistics, which also recommended the establishment of an independent crime statistics body. The Government has committed to introducing an independent crime statistics agency in line with the Ombudsman's recommendation. Options for implementation are currently being analysed and considered by the Government. The Committee's recommendation will be considered as part of this piece of work.
25. The limitations on Council activity in the community safety area can often be attributed to the lack of adequate and specifically tailored/dedicated funding. The Committee therefore recommends that appropriate funding opportunities be offered to local government to drive more targeted, evidence-based community safety activity. 26. The Committee recommends that the Victorian Government provide further and ongoing grants for community crime prevention and safety initiatives, particularly those involving partnerships. The Committee recommends that as a requirement of receiving Victorian Government funding for crime prevention, local governments either by themselves or in conjunction with other local councils in their regions are required to establish local safety committees that foster crime prevention and community safety partnerships.	Support in principle	The Government supports and encourages local and regional collaboration and the formation of meaningful partnerships to foster effective crime prevention approaches. However, as noted in recommendation 15 and 16, councils' governance, committee structure and partnership arrangements are a matter for individual local councils, having regard to their local needs and resources.
28. The Committee recommends that as a requirement for obtaining a crime prevention grant, councils, shires and local community organisations be required to demonstrate to the Community Crime Prevention Unit that the initiative for which they are seeking funding addresses an identified problem in the community and falls within a priority of the local crime prevention and community safety strategy. Such evidence could be provided through the local crime prevention audit/needs analysis and/or by accessing police statistics, research and other intelligence data.	Support in principle	The Government notes that the current guidelines for grants under the Community Crime Prevention Program require applicants to document the problem to be addressed (including evidence of the problem) and how the proposed solution will address the identified issue. As noted in recommendation 9, the Government agrees that local government action in relation to crime prevention should be informed by evidence and form part of a strategic response.
 29. The Committee recommends that the Community Crime Prevention Unit should develop a series of training packages on crime prevention and community safety. These modules should support the attainment of skills and knowledge required for job roles that involve the identification, planning, development or delivery of crime prevention strategies or activities. Course content could include the following: understanding crime prevention theory and practice the various approaches to crime prevention 	Support in principle	The primary function of the Department of Justice's Community Crime Prevention Unit is the administration of grants under the Community Crime Prevention Program. The Unit also develops tools and resources to help build local community crime prevention capability, including Information forums in relation to its grants programs. 30. The Committee recommends that comprehensive units on crime prevention and community safety should be incorporated into Victoria Police probationary training as soon as possible. 32. The Committee recommends that Victoria Police should provide a clear statement of what the public should do when it observes any suspected criminal activity.	Support	Victoria Police is undertaking consultation with Crime Stoppers Victoria and Neighbourhood Watch Victoria to inform an effective communications statement which will clearly define what the public should do when it observes suspected criminal activity and requires a police response.
33. The Committee recommends that the Community Crime Prevention Unit investigate the promotion of Facebook and other forms of social media in developing and implementing crime prevention initiatives.	Support	The Government recognises the role that social media can play in supporting the development and implementation of crime prevention initiatives. Victoria Police is currently trialling EyeWatch, a facebook-based online forum that aims to empower local communities to participate in crime prevention activities. Any additional activities impacting funding or programs would be subject to Government consideration through the normal state budget process.

The Committee recommends that the Community Crime Prevention Unit liaise with, encourage and assist university architecture and planning faculties to offer or expand courses on Crime Prevention through Environmental Design.	Support in principle	The Government recognises that Victoria's autonomous universities play a leading role in creating and imparting knowledge that supports society to address a wide range of challenges. Universities continually evolve their course offerings to ensure that they produce work-ready graduates that are prepared to meet the needs of the community, industry and government. The Government supports cooperative working relationships with university architecture faculties so that their courses are better informed by contemporary crime prevention principles.
		The Government notes that Crime Prevention Through Environmental Design principles are embedded in the Safer Design Guidelines for Victoria. Safer design is embedded in good urban design principles. The Department of Planning and Community Development has established relationships with Victorian tertiary institutions with architecture and planning faculties, and it currently provides a range of additional training for urban design and planning professionals across industry and local government.
35. The Committee recommends the Victorian Government consider establishing a Designing Out Crime Research Centre in Victoria similar to that operating at the University of Technology, Sydney NSW.	Support	The Government will consider the feasibility of establishing a centre to similar to the NSW Designing Out Crime Research Centre. Any decision will be subject to Government consideration through the normal state budget process.
36. The Committee recommends that Neighbourhood Watch as part of its current funding requirements be reviewed by the Victorian Government in 2013. The Review would assess the effectiveness of Neighbourhood Watch as a government funded crime prevention initiative. It should also indicate on the evidence received whether on balance further government funding should be allocated to support Neighbourhood Watch beyond 2014.	Support in principle	The Government has committed \$550,000 in funding over the four years to 2014/15 to help reinvigorate Neighbourhood Watch and enable it to achieve a sustainable and independent operating model. The normal state budget process requires all proposals seeking funding to have a cost-benefit analysis and, where funding has previously been provided, an evaluation of outcomes.
