





Self Determination and Treaty



Self Determination and Community Infrastructure

The 2017-18 Victorian Budget will invest \$21.8m over four years in community infrastructure to support self-determination. This supports two key programs:

A Community Infrastructure Project Fund to support larger grants for significant infrastructure projects.

This aims to strengthen the economic capacity and sustainability of Aboriginal organisations to move towards greater self-determination by leveraging their assets to build business ventures and generate greater prosperity.

Support will also be delivered for business case development.





Victorian Aboriginal Economic Development

Aboriginal Business Development and Procurement:

- Tharamba Bugheen: Victorian Aboriginal Business Strategy 2017-2021 released in March 2017 (progress to be overseen by the Board).
- One per cent government procurement target from Aboriginal businesses announced in March 2017.

The Victorian Aboriginal Economic Board:

- Established in 2016 and pursuing an ambitious work program against three key priorities:
 - place-based approaches
 - Aboriginal procurement
 - o innovation and entrepreneurship.
- Held its first public event in March 2017, the Geelong Employer Forum, where nine local employers signed the Geelong Aboriginal Employment Agreement to improve Aboriginal employment outcomes.

Aboriginal Public Sector Employment:

The Victorian Public Service is only 57 more Aboriginal employees away from meeting its 1.0 per cent employment target.



A total of 1120 Aboriginal Places have been added to the Aboriginal Heritage Register between 1 April 2016 to 1 April 2017

Aboriginal Victoria and Registered Aboriginal Parties have approved 417 Cultural Heritage Management Plans in the Financial Year to 31 March 2017 (estimated to be 600 for the year). This is an increase of 50% on previous years.
