
Meetings and problems we have had

State Planning seems to have applied absolutely NO tailoring of new controls or HCTZ for Heritage precincts or places

No involvement by any Heritage Stakeholders in design of controls. Narrow input by Development Industry ONLY Confusion for community and councils: Heritage Overlay will become undermined and ineffective despite State Planning "HO remains" response

Could impact 50,000 heritage houses in Victoria* *Charter 29

3-6 storey buildings in 1-2 storey historic streetscapes & conservation areas are contrary to Australian cultural heritage and conservation principles

We can't get any confirmation from our government sadly, but our conclusion is: Fast and "forever" residential heritage streetscape deterioration will happen

New controls give blanket approval for 3-6 storeys on non contributory lots on narrow residential heritage streets.

Communities likely to ultimately disengage with their custodian role at their home and in their heritage precinct.

These disruptive, overpowering forms will according to the controls be encouraged by the HCTZ in heritage overlays on all streets. (most only 6-8m wide)
