Key Achievements 2010-2011

Parliament of Victoria

- Implementation of the November 2010 election results:
 - 28 seats changed over
 - 54 electorate office audits and handovers completed within 20 days of the first poll declared
 - 28 new MP's surveyed: 18 responses: 93 % positive
 - 27 former MP's surveyed: 10 responses: 90 % positive
 - \$1.14 million cost met from internal budget and service cuts
- Opening of the 57th Parliament
- Webcasting of Parliamentary Proceedings
- Development of the Precinct Master Plan
- Completion of Stages 3 & 4 of the Stonework Restoration Project

Key Challenges in 2011-12

- Establishment of the 57th Parliament including Parliamentary
 Committees, electorate offices and other support infrastructure.
- Ensuring that Parliament House remains a functional contemporary working location within the constraints imposed by its heritage characteristics.
- Delivering an appropriate range of services within existing resources and against a background of rising costs and increasing service needs.
- Enhancing citizen participation by expanding the Community Engagement program.
- Extending the video broadcasting of proceedings in the Legislative Council, Legislative Assembly and Committees;
- Upgrading Parliament Precinct security whilst maintaining public access to Parliament House.
- Training and retention of staff specialising in Parliamentary procedure.

Key Challenges in 2011-12: Parliament Precinct

Parliament of Victoria

- Parliament House has been in use as the seat for the Victorian Parliament continuously for 156 years
- Despite its imposing façade and public areas, the building was never completed due to costs, and decades of funding restrictions led to minimal maintenance to the infrastructure and fabric of the building
- As a result the current functioning of the building is compromised by:
 - Obsolete infrastructure like sewerage, plumbing, electricity and ventilation
 - Obsolete fire detection system non functional for 4 weeks in 2010
 - Sections of stone falling from the building presenting a major OH&S risk
 - Failing stonework allows water to enter the building further damaging stone and damaging plaster and paintwork
 - Water penetration placing National Gallery and Parliament Art Works and heritage collection at risk
- Stone Restoration Work aims to make the building waterproof so as to allow internal restoration to commence at a later date, and to address safety concerns from falling stonework
- The current stone restoration works commenced in 2006 and are proceeding in stages around the building. Stages 1 to 4 of the works include the east and south walls of the Legislative Council wing and the south and east walls of the library wing.
- Stages 3 and 4 are currently in progress and due to be completed in June 2011.
- Stage 5 funding of \$4.0 million for 2011-2012 received in the State Budget.






Sandstone condition

Pilaster blocks coming away from the building






Deterioration of the lower cornice soffit caused by the penetration of water presents a risk to safety from falling elements.




STAGING DIAGRAM
