



Investing in a strong child protection system

- Record investment over the past six years in Child Protection policy and legislative reform
- \$77 million Child Protection boost will provide for 101 frontline Child Protection staff to ensure that Victoria's most vulnerable children are protected




Further \$33 million investment in 2010-11 to support family services, improve accountability and monitoring of child protection practice, workforce retention and improving our responses to sexual assault and child abuse

 Further \$34.8M investment in 2009-10 to improve outcomes in out of home care


Specialist Support and Placement Services Output to 2010-11




- Strong focus on ensuring community safety through early intervention programs and support services for young offenders.
- More programs to tackle offending, violence, behavioural problems and mental health issues. Further investment in tackling offending in 2010-11 of \$22M, to include 55 new workers.
- More early intervention strategies in place. Lowest rates of young people under youth justice supervision in Australia.
- Refugee Minor program reconfigured to meet the complex needs of more recent arrivals. Further investment of \$3.8M.



- Total output budget increase \$798.5M or over 139 per cent since 1999-2000




+ 2009 Bushfire Recovery


