Principles

- Supported to actively participate in the codesign and consultation processes to support self-determination.
- Supported to participate in project governance to ensure that resident voices are heard in meaningful ways regarding decisions and processes that directly impact them.
- Trauma informed and culturally safe practices will underpin the delivery of the project.

Resident engagement/ codesign ensures that residents are:

- Aware of what is happening and what is planned for the future.
- Have a reliable source of truth
- Opportunities to be involved in key decisions impacting their lives.
- Opportunity to build and/or consolidate strong linkages between residents and Homes Victoria.
- New housing designs; adapting to living in different environments.

- Strengths based approach, culturally sensitive and trauma informed
- Translating previous research to practice
- Utilisation of a robust evidence based methodology; replicability and scalability
- Adaptable, agile and iterative approach guided by resident feedback

Learnings from activities to date

Residents

Engage early and co-design; before an offer of relocation

Recognise the importance of the individual journey

Acknowledge the grief and loss

Create a shared vision with residents – What does a new home look like in 12 months time?

Build trust; host respectful, culturally sensitive social in information sharing events based on resident feedback

Communities/Partnerships

Recognise and share expertise

Harness the power of our collective formal and informal data, particularly the grey literature

Problem solve together

Bring the right stakeholders to the table at the right time as determined by the residents

Permission and scope to operate "outside of the box" solution generation



Issue 1: Design to address safety and security concerns

Context

Better Start report

Resident insights

- Safety fear is a barrier to relocation
- Safety and security is a concern for residents remaining at 259 whilst relocation is occurring

Resident feedback

- Increased feeling of safety in new location
- Enablers include relocation with existing social support networks, building design features such as secure community gardens, pass protected lifts, support for resettlement

Opportunity to affect generational change

Application of gender specific design principles to support delivery of better outcomes for vulnerable children in First 1000 days



Issue 2: Diversity of the resident population

Evidence based "case studies" describing health and wellbeing needs, health literacy and ability to engage in our rapidly evolving digital world

Resident insights

Case studies guiding the development of information sessions, preparation for moving and settlement support activities

Topics include; Rights as a resident, Difference between Community Housing and Social Housing, practical activities such as how to manage downsizing, Criteria for and how to apply for Special Consideration when relocating; what documentation you will need and who can provide it
