#### AGRICULTURE AND FOOD SECURITY PORTFOLIO

#### Question 1:

Please provide particulars about what components make up the following spending reduction targets for the Agriculture and Food Security portfolio in 2013-14:

- a. savings initiatives from previous budgets (estimated at approximately \$40 million in the hearing); and
- b. 'existing resources' reductions (Budget Paper No.3 *2013-14 Service Delivery*, p.11, estimated at approximately \$5 million for 2013-14 in the hearing).

(Page 6 of the Agriculture and Food Security portfolio transcript)

#### Reply:

a) Our Government's economic reform strategy seeks to manage the current economic challenges in order to position the Victorian economy to take advantage of new opportunities. We are building a stronger budget position across the forward estimates period by promoting productivity and achieving efficiency gains within DEPI.

The Department of Environment and Primary Industries (DEPI) budget is in line with the Government's long term financial management objectives, being:

- Managing responsibly
- Looking after the future
- Managing the unexpected
- Improving services
- Maximising community benefit.

As our Government has indicated, the department is implementing efficiencies and savings that have been implemented by both the former Department of Sustainability and Environment and Department of Primary Industries. The savings target is for the consolidated department, that is DEPI.

The efficiencies and savings identified by DEPI ensure that there is no impact on service delivery and will focus on:

- moving to a regionally based delivery structure
- head office, non-service delivery administrative savings, stocks and materials
- freeze on recruitment to bring staff back to historical levels
- lapsing of fixed term positions

- corporate reform
- natural attrition
- Voluntary Departure Program through the Sustainable Government Initiative.

Savings targets are in line with whole of government ratios.

b) In the 2013-14 budget, our Government has provided approximately \$140 million in funding for DEPI initiatives. In light of the current fiscal environment, the Department has identified areas where existing resources can be used to fund these new initiatives, without impact on service delivery. Existing resources include reprioritisation of programs that have experienced slower than anticipated take up, and revenue from licences issued by the Department.

#### Question 2:

Will any steps be undertaken to prevent the increased cost to water authorities resulting from the change in the financial accommodation levy being passed on to consumers?

#### Reply:

The Water Authority Prices are determined by the Essential Services Commission (ESC). There are no specific steps taken by the ESC to prevent the increased costs resulting from the changes in Financial Accommodation Levy (FAL) being passed on to customers. The FAL is taken into account by the ESC when they make their final determination on setting a rate for the weighted average cost of capital (WACC) that Water Authorities can use. The most recent WACC was based upon current market conditions, which takes into account both debt raising costs and the Financial Accommodation Levy (FAL).

#### **Question 3:**

Please quantify the additional charges that each water authority will be required to pay as a result of the change to the financial accommodation levy.

(Page 12 of the Water portfolio transcript)

#### Reply:

The Financial Accommodation Levy as per the 2013/14 budget for 2012/13 is \$91.7 million.

#### **Question 4:**

Please provide the number water efficiency rebates applied for (as distinct from approved) in each of the following two categories:

- a. small business; and
- b. home and garden.

(Page 13 of the Water portfolio transcript)

### Reply:

- a. 642 (including 608 approved); and
- b. **15,888** (including 14,491 approved).

#### Please note:

- a) The data above is relevant for 1 July 2012 to 31 May 2013. Rebate data is still being reported by water corporations for June 2013.
- b) The rejection of rebates occur for a variety of reasons. Common examples include products not meeting the specified minimum water ratings or standards, and plumbing works not meeting minimum regulations.
