Thank you for your letter on 14 August 2025 regarding petition no. 664 tabled in the Legislative Council.

Since 2014, the Victorian Government has invested \$177 million into making Victoria's fisheries the best in Australia, which includes:

- Establishing Australia's only dedicated fisheries authority, with a mandate to grow fishing in Victoria.
- · Making public boat ramps in Victoria free.
- We have removed the 700-ton annual commercial fishery which means there are 700 tons more fish in the bay every year. In addition, we know recreational fishers do the right thing with over 90% compliance with our fishing bag and size limits
- Stocking 10 million fish into Victoria's waterways each year, more than every state and territory in Australia combined.
- Having invested in over 100 boating improvement projects including major boat ramp upgrades at Mahers Landing, Cowes, Rhyll, Lake Boga, Loch Sport, Echuca, Mildura, and Torquay.
- Providing 95,000 free fishing rods to Victorian primary school students.
- Allocating \$1.6m to Victoria's 330 angling clubs to help the clubs modernise and attract new members; and
- Providing \$2.5m towards habitat grants and improving our river health.

We now have over 1 million Victorians fishing every year and our fisheries are the envy of Australia.

The VFA completed a comprehensive consultation process with staff, and the final structure was announced to staff on 20 May 2025 and is now operational.

The restructuring reflects a modern, efficient fishery, maintains sustainability, and delivers required government savings.

The new structure improves the VFA operating model so it can efficiently and effectively address the modern fisheries management environments:

- The Statewide Investigations Group has been relaunched as the Major Fisheries Crime Unit, now with enhanced focus and additional resources.
- Across the board, the VFA continues to maintain fisheries at record levels, ensuring that all species are harvested sustainably.
- It retains Fisheries Officer positions across Victoria, including around Port Philip Bay and Western Port.
- It retains strong science capability for the management of the commercial and recreational fishing sectors.
- It retains the fish breeding and stocking program including for recreational and endangered species.
- The 13FISH reporting line remains operational to call if people see anyone doing the wrong thing
