## Dear PAEC Committee,

I have been asked my Mayor Kellander from Hobsons Bay to comment on the following questions:

The Committee requests that the following two questions be reviewed and answered by all elected members of your Council:

- 1. How comfortable are you with the current use of confidentially in meetings within your Councils?
  - I am not at all comfortable with the current use of confidentiality in meetings. Obviously if there is a contractual arrangement or something of a personal nature, it should be confidential. In the normal course of events, most of the issues that are brought up are not of a confidential nature and could easily be shared with the residents and ratepayers. This would enhance the idea of open, transparent and accountable government, instead of fostering a perception of shady dealings.
- 2. How could the need for confidentiality be better balanced with the requirement for Council decisions to be reported transparently?
  - Council officers need to understand that the public demand to know where their money is going and how it is spent, the perception from the general public is that it isn't been spent wisely. There is almost no accountability, councillors are repeatedly told, that's operation and so outside our sphere of influence.
     Councillors are elected by the public as sort of Directors of a company and we are hamstrung by bureaucracy who are not willing to show us what they do in case there is an adverse reaction.
  - The need for transparency is paramount if councils ever want to regain public trust, council officers need to be fully accountable to residents and ratepayers.
