#### (e) Member's objectives:

The purpose of this travel was to engage with New Zealand political leaders and advocacy groups who played a role in the national ban on greyhound racing.

Victoria, particularly regional areas within Northern Victoria, continues to face growing community pressure around animal welfare issues in racing. Rising deaths and injuries on tracks, particularly those located within Northern Victoria, is an issue I receive regular constituent correspondence about.

This trip allowed me to gather insights into how New Zealand successfully transitioned away from greyhound racing, what political and legislative levers were used, and how public and industry consultation was managed.

I also used this opportunity to better understand cross-party support strategies and how to build coalition support for similar legislative movements in the Victorian Parliament.

- Successful models of community engagement and messaging that swayed public opinion.
- Evidence of broad-based political support through cross-party alliances that could inform Victorian strategy.
- Lessons learned from logistical and transitional challenges that NZ faced, helping shape any recommendations for a similar approach in Australia.
- A deepened understanding on the importance of an independent inquiry into greyhound welfare standards and injuries.
- The importance of integrating insights from into greyhound community advocacy strategy across Northern Victoria.
