Reply:

The 2024-25 Budget of \$1,729.2 million for the Emergency Management Capability output cost on pages 155 and 153 of BP includes, but is not limited to, grant payments to Emergency Services Organisations.

The estimated grant payments to Emergency Services Organisations in 2024-25 include:

- VICSES \$74.9 million*
- FRV \$797.6 million*
- CFA \$337.6 million*
- TZV \$126.5 million
- LSV \$17.3 million

*Inclusive of budget managed by the department directly on behalf of Emergency Services Organisations, such as for Emergency Management Operational Communications.

Question: How many firefighters are currently unable to perform their full duties due to the ongoing COVID-19 vaccine mandate with FRV?

Reply:

The Victorian Government and Fire Rescue Victoria take the health and safety of emergency service members seriously. FRV ensures its workplaces are, so far as reasonably practicable, safe and without risks to health and safety. Vaccination requirements for FRV firefighters is a matter for FRV.

I am advised the number of FRV employees currently not working due to non-compliance with the FRV COVID vaccination requirements is 18.

Question: Minister, on the FRV, I can see here from some of the statistics they were not able to meet their target response time – that is, 90 per cent for structural fires – in 2022. The actual was 83.7 per cent. There was some discussion within the department. I know there was a document released in respect to whether this was as a consequence of the cyber attack that occurred. Are you able to shed any light on that and whether in fact the paper operation that had to occur after the cyber attack has now ceased entirely and we are back up and running? So you resorted to using pen and paper because of a cyber attack on FRV's system.

Reply:

The cyber-attack in December 2022 shut-down the electronic and automated Station Turnout System (STO). Following the attack manual processes such as pagers, were temporarily used to dispatch crews. The STO was restored in August 2023. The decrease in Fire Rescue Victoria's response time performance in 2022-23 was caused by an increase in the time taken to 'turn out' (mobilise). This is the time it takes firefighters to depart the station after crews are dispatched to an incident. The time taken to arrive on scene, after leaving the station, remained constant. FRV's response times have improved since reinstatement of the STO.
