Permission for this activity may be granted through a letter of approval where the primary objective of the covenant is the conservation of the natural and cultural environment and, on balance, the arrangements will deliver important conservation outcomes that could not otherwise be achieved.

The covenanting of Heart Morass is such a case. The work undertaken through the Heart Morass Restoration Action Plan highlights a comprehensive restoration management plan with a hierarchy of conservation objectives. The land is of exceptional ecological value and it is not practicable to exclude duck and Stubble Quail hunting within the area subject to the covenant.

It is noted that all hunting activity permitted by this letter of approval must be in accordance with the management guidelines set out in the Management Plan. This Letter of Approval applies to the Tier 2 of the covenant only, and no permission is granted to allow hunting activities within Tier 1 (offset area).

Approval is provided for the activities set out below as follows:

 The use of your covenanted land for seasonal duck and Stubble Quail hunting by licensed hunters provided it is undertaken on a sustainable basis and does not have any adverse impacts on the wetlands. It must also be in accordance with the law and any other applicable government requirements including those relating to season length, permissible species, bag limits and use of dogs. The number of licensed duck and Stubble Quail hunters on the land must be managed to avoid adverse impacts on the covenanted area.


