Production of documents – Multi purpose taxi program trial

I refer to the Legislative Council's resolution of 3 February 2021 requiring the production of documents detailing the design of the Multi Purpose Taxi Program trial, including, but not limited to all documents—

- (1) detailing the way in which trial participants were recruited, contacted and selected;
- (2) detailing the results of the trial;
- (3) detailing risk assessments conducted for the trial;
- (4) relating to the impact assessments, both financial or otherwise, conducted for the trial; and
- (5) relating to the consideration given to unintended consequences to services provided in the broader disability sector, in particular services provided by wheelchair accessible vehicles.

The Order required production of the documents within 28 days of the resolution.

I also refer to the letters to you from former Attorneys-General, the Hon. Martin Pakula MP and the Hon. Jill Hennessy MP of 14 April 2015 and 20 February 2019 respectively, noting the limits on the Legislative Council's power to call for documents. Those limits centre on the protection of the public interest. These letters set out the factors the government would consider in assessing whether the release of documents would be prejudicial to the public interest.

I note that the wording in the Legislative Council's 3 February 2021 resolution was particularly broad and that the clear focus in the Legislative Council debate was on the Uber trial that occurred in Geelong over March to May 2020. The government formed the view that the documents referred to in the Order include:

- documents relating to the design and implementation of the Multi Purpose Taxi
 Program expansion generally, including the Department of Transport's specifications
 and documents relating to the contacting, recruitment and selection of participants
 generally; and
- documents relating to the Uber trial in Geelong, including all documents that may fall within sub-paragraphs (1)-(5) of the Order.

In line with this interpretation, the government has conducted a thorough and diligent search to identify the documents that may be relevant to the Council's resolution. It identified 103 documents that fall within the scope of the Council's order.



The government, on behalf of the Crown, makes a claim of executive privilege in relation to 27 of the documents in full and 11 of the documents in part, on the basis that their disclosure would be contrary to the public interest. The attached schedule refers to the documents in respect of which a claim of executive privilege is made.

Some of the documents produced by the government contain the personal information of individuals. In the interests of personal privacy, those details have been redacted.
