Letter of Complaint re "unlawful abduction and forced adoption"

Re: Unlawful Abduction and Forced Adoption of [REDACTED] on [REDACTED]
[REDACTED] ("Without Consent" - "Taken Not Given")

My name is [REDACTED] (DOB [REDACTED]) and I writing in relation to my son, [REDACTED] having been unlawfully abducted on [REDACTED] [REDACTED] at St. John of God Hospital, Warrnambool and unlawfully abducted and forcibly adopted on [REDACTED] from St. John of God Hospital, Warrnambool at approximately [11:30am](#)) and my home in Warrnambool at approximately [12:30pm](#) by two Department of Health and Human Services Adoption Agency representatives (Mrs. [REDACTED], Principle of Adoptions, Catholic Family Welfare Bureau, Melbourne (now CatholicCare) and Mr. [REDACTED], Social Worker and Relationships Counselor, Catholic Family Welfare Bureau, Ballarat. Attached is a flow chart identifying all those unlawfully involved in this heinous crime who conspired with [REDACTED] and [REDACTED]. In this letter I will address how this crime occurred from it's inception by my then GP, Dr. [REDACTED]. I am requesting to have my claims against DHHS Adoptions Agency, CatholicCare in relation to my son's unlawful abduction and forced adoption fully investigated by DHHS. I am requesting financial compensation, formal recognition and full written apologies for myself and my son admitting that my son was illegally taken from my care without my knowledge or consent under the watch of the Department of Health and Human Services by their Agency, CatholicCare staff.

NOTE. Mr [REDACTED] rang me at work in late June having been given my personal contact details by Dr. [REDACTED]. Mr. [REDACTED] advised as a Couples Counselor he could help me and my son's father with relationship counseling. This is the only reason I agreed to meet with Mr. [REDACTED] at my home on [REDACTED] and [REDACTED]. His intention from the start unbeknown to me was to remove my son from my care, which he succeeded in doing on [REDACTED] and completed on [REDACTED].

I advise that from September 2017 to date, I have done all within my power to contact and give those organisations involved in this heinous crime the opportunity to meet with me directly to resolve this matter and to bring it to a satisfactory resolution for my son and myself without success. I have contacted

Ms. Netty Horton, CEO, Catholic Care, Melbourne, Ms. [REDACTED], Trustee, St John of God Health, Subiaco, WA, Dr. [REDACTED] (attending GP), Sister [REDACTED] [REDACTED] St. John of God, Subiaco, WA and several Senior Clergy of the Catholic Diocese of Melbourne, Ballarat and Perth and the Victorian Police who have all either ignored me or have denied any involvement in this heinous crime. Since my son (aka [REDACTED]) contacted me in May 2011, I have through numerous Freedom of Information requests been able to obtain a large number of documents from both CatholicCare and St. John of God Hospital, Warrnambool which have enabled me to investigate this crime and uncover the truth which I submit to you today on my son's [REDACTED] birthday. A day which is not a celebration for either of us. For me it will always be "abduction day." Every year I struggle to make it through October. All documents in my possession are available on request. Please note that Dr. [REDACTED] has destroyed all records of my son's birth and denies either of us were his patients in [REDACTED]

NOTE: Porters Lawyers, Canberra took my case on on a "no win, no pay" basis is April 2013 and refused to proceed with "no win, no pay" when all parties involved refused to come to the table to negotiate financial compensation in late 2015. Needless to say this had a serious effect on my mental health and caused suicidal thoughts on several occasions throughout this unprofessional legal process.

NOTE: I would not recommend Porters Lawyers to anyone affected by forced adoption. They do more damage to victims in my view. Also note Porters Lawyers ([REDACTED]) told me to go to the Police, which I did in mid 2015, again to no avail.

As you can see I have followed all avenues to resolve this issue before lodging this Complaint with DHHS.

I wish to highlight some of the major events which occurred in [REDACTED] in relation to my son's Unlawful Abduction and Forced Adoption. There are numerous events still to be addressed, but I have narrowed them down in this initial submission.

In the 1964 Adoption act for "adoption of children", it states in point 28 of "Defective Consents" 2.

“Without prejudice to the application of the last preceding sub-section in relation to the consent of the mother of the child, the Court shall not make an adoption order in reliance on an instrument of consent signed by the mother of the child within five days after the birth of the child.”

The first incriminating document I wish to bring to your attention is:

The attached letter dated [REDACTED] (the day my son was born) written mid morning at St. John of God Hospital, Warrnambool by Mr. [REDACTED] [REDACTED] Social Worker, CFWB (CatholicCare) in the presence of Sister [REDACTED] [REDACTED] and my Aunt [REDACTED] [REDACTED] [REDACTED] and addressed to Dr. [REDACTED] [REDACTED] to arrange my son's forced adoption and thanking Dr. [REDACTED] for his cooperation in arranging for my son's forced adoption to be finalized on [REDACTED] at St. John of God hospital, Warrnambool. Dr. [REDACTED] [REDACTED], [REDACTED], Sister [REDACTED] [REDACTED], [REDACTED] and Midwife [REDACTED] [REDACTED] and student nurse [REDACTED] were the major perpetrators instrumental in my son's unlawful abduction and forced adoption. This letter shows a clear violation of the 1964 Adoption Law of obtaining consent from the mother of the child 5 days after the birth (stated above). Please note [REDACTED] did not speak to me at the hospital on [REDACTED]. I had had no contact with [REDACTED] since [REDACTED], when I informed him I was not having my child adopted as he aggressively suggested on that day. At no time was adoption mentioned or discussed with me at the hospital or were adoption papers presented to me for completion or signature during my 5 day hospital confinement. Please note the Adoption Papers [REDACTED] forced me to sign under duress and aggressive bullying at my home on [REDACTED] were completed by Mrs. [REDACTED]. At no time did I contact CFWB requesting the adoption of my son. This was all arranged by Dr. [REDACTED] who violated Doctor/Patient Confidentiality by passing my medical records, my home address and my work phone number onto Mr. [REDACTED] Social Worker and Couples Counselor, Catholic Family Welfare Bureau, Ballarat on or about [REDACTED]. See attached document written by Dr. [REDACTED] at Warrnambool and District Base Hospital identifying my son for adoption. Note: I did not attend this examination as claimed by Dr. [REDACTED]. In fact I was unaware Dr. [REDACTED] had booked me into the Warrnambool and District Base Hospital until I received my medical records from St. John of God Hospital, Warrnambool in [REDACTED].

NOTE: [REDACTED] and [REDACTED] had my son in their car. [REDACTED] told me when I signed the papers (at no time mentioning they were adoption paper) he would bring my son to me. I did not know that I had signed adoption papers. How could I as I did not request adoption or complete adoption request paper work. After being bullied into signing the paperwork so [REDACTED] would hand my son [REDACTED] to me, I followed [REDACTED] to his car. When I saw the woman ([REDACTED] in the passenger seat, I realized she must have [REDACTED] I went to open the passenger front door and as I reached for the handle, [REDACTED] turned without looking at me and pressed the door lock button down. I could not see [REDACTED] all I could see was a colored baby blanket in her ([REDACTED] lap. I panicked, not understanding what was happening and ran around the back of the car to the driver side where [REDACTED] was standing, [REDACTED] forcibly pushed me to the ground, got in the car and drove away with my baby son, [REDACTED] leaving me numb, disoriented and unable to feel anymore. There could be no more feelings or I would not have been able to go on and the only reason I live today is because my son exists. An emotionally broken down state from which I have and will never recover until the day I die. I had lost everything, my son, family, friends and had been made an outcast by society and forbidden to grieve my loss or speak of my son to anyone. In [REDACTED] I emmigrated to Canada thinking I could leave my pain behind. It did not work, I threw myself into a career and became a very driven "corporate zombie," burying 200% of myself in a successful career. Had I requested and consented to my son's adoption, my signature would have been the first signature on the papers, but it was in fact the last. The adoption papers are in fact, ILLEGAL and were witnessed at St. John of God Hospital, Warrnambool by [REDACTED], Commissioner for Affidavits, without my signature on them.

NOTE: There is no happy ending to my story as my son chooses to blame me for his "unlawful abduction" and "forced adoption" after contacting me in May 2011 and choose not to have a relationship with me which has deprived me of meeting my two granddaughters aged [REDACTED] and [REDACTED] months old. Adoption is a life sentence and I have in fact now lost three children in my lifetime. The pain and suffering is front and centre of my every day life and that will not change.

This clearly indicates that all those involved in the conspiracy to unlawfully remove my son from my care broke the law under the guise of the Department of Health and Human Services being CatholicCare aided and abetted by Dr. [REDACTED]

██████████ and several other members of the medical profession and ██████████, Commissioner for Affidavits.

NOTE: Sister ██████████, Head Nun, St. John of God Hospital Warrnambool handed my son over to ██████████ and ██████████ on or about 11:30am on ██████████. See attached document.

NOTE: Sister ██████████, forcibly pushed me out of the hospital nursery on ██████████ after a nurse told me Dr. ██████████ had not cleared my son to go home the same day as me. I was emotionally distraught and did not understand what was happening to me and why I could not take my son home with me. I thought there must be something seriously wrong with him that they would not tell me. Nothing made sense to me as I was very distraught at the way I was being mistreated by ██████████ and the hospital staff. ██████████ physically pushed me from the nursery and out of the hospital main entrance and refused to let me back in to see my baby. The nurse had told me, "everything will be sorted out on Monday." Only now after my investigation into my case do I understand what she meant.

The second major event I wish to address is the fact that CatholicCare staff made the decision to choose "replacement parents" for my son who are both LEGALLY BLIND, violating my son's Human Rights and denying him the right to reach his full potential. See attached letter from CatholicCare to the "replacement parents" Mr. and Mrs. ██████████ at their request.

NOTE: the Author of this document was withheld by DHHS FIND lawyers in September 2017 under Freedom of Information request made to them by me. It is my firm belief that the author of this document is Mrs. ██████████, Principle Adoptions, CatholicCare, Melbourne. The date I believe this letter was written on or about late ██████████.

NOTE: Mr. ██████████ has been blind since birth and Mrs. ██████████ is legally blind and has a seeing eye dog.

In addition to the points I have already raised, I now wish to address some other events I am now aware of that exemplify the actions of forced adoption, which provides context to the actions of ██████████ and ██████████ ██████████ CatholicCare in the Unlawful Abduction and Forced Adoption of ██████████

██████████ on ██████████ and ██████████ respectively aided and abetted by Dr. ██████████, Sister ██████████, Nurse ██████████ and ██████████ and several other medical professionals and ██████████ Commissioner for Affidavits.

NOTE. ██████████, Commissioner for Affidavits was not present when the "Form of consent by parent to adoption order" was forcibly signed at my home on ██████████. All 3 parties myself, ██████████, mother of ██████████, Mr. ██████████ and ██████████ Commissioner for Affidavits, had to be present in the same location (using the same pen, which is a legal requirement) for the adoption papers to be signed and making adoption of my son legal. This did not occur. The adoption papers were, in fact completed by ██████████ in advance and signed and witnessed by ██████████ at St. John of God Hospital, Warrnambool some time between 10:30am and 11:30am when ██████████ and ██████████ unlawfully abducted my son and without my signature on the adoption papers as I was not present.

NOTE: The pen used at my flat when ██████████ bullied me into signing documents I had never seen before was the third or fourth pen used. 1st pen used by ██████████ to complete the adoptions forms. Second pen used by ██████████ and ██████████ when document signed by them both, without my signature. Then the pen used at my flat. I have an original copy of these ILLEGAL Adoption Papers in my possession, which are available on demand.

To date, I have made four separate Freedom of Information requests to CatholicCare for a full copy of my adoption file. One of these requests being through DHHS FIND in 2017. I firmly believe that CatholicCare are still withholding relevant documents from my case file pertaining to my son's "unlawful abduction and forced adoption." This claim also needs to be addressed as part of this investigation into unlawful practices by CatholicCare as a DHHS Agent for adoption.

NOTE: "Open Adoption" was in the pipeline in 1982 and became law in the 1984 changes to the Adoption Act. And in fact Mrs ██████████ was a consulting Member of the Victorian State Government Cabinet Committee representing CatholicCare from ██████████. Mr. ██████████ also consulted in relation to recommended changes to the Adoption Act in 1983 and

1984 (notation in State Government Gazette showing Mr [REDACTED] as a participant.) As both [REDACTED] and [REDACTED] were involved in consultation with the Victorian State Government in relation to the changes to the Adoption Act passed in 1984, neither of them can deny that they did not know the law they willfully broke in 1982 when they "unlawfully abducted and forcibly adopted my son."

I look forward to a response from you in a timely manner.
