  - 3. If he will endeavour to improve the marketing facilities, and generally look into the difficulties with which the industry is being carried on, and remove any injustices.

As far as I am concerned, I have no objection to the claim, but I am of Mr Wilson's way of thinking. What I say is that a soldier does not cease to be a citizen by his departure from the Commonwealth. He retains his rights as an elector, and so clearly enjoys all the other rights a citizen has."
