NORMAL SCHOOL CORRESPONDENCE.

Copies of all Correspondence between the two Boards of Education and the Government, on the subject of the formation of a Normal School.

> Denominational School Office, Melbourne, 7th March, 1853.

SIR,

I have the honor to address you on the subject of a letter which I have received Enclosure No. 1. from the Secretary of the National Board of Education in this Colony, and of which a copy is enclosed.—That Board propose that the Denominational School Board should provide two-fifths of the costs of the erection of Normal School Buildings in Melbourne, estimated at £20,000, and offer two-fifths of the advantages of the proposed Institution for the limited term of ten years, in consideration of the sum of £800 to be contributed by them.

It is understood that the management of the Institution is to reside altogether in the National Board, and that it is to be conducted on their principles. The Denominational School Board feel it to be their duty to submit a matter of such grave importance to the consideration of His Excellency the Lieutenant Governor, more especially as they have been led to believe that the present arrangement, under which the Department of Education is administered by two co-existing Boards is only temporary, and will be superseded at an early period by a combined system.

The propositions of the National Board, however, appear to be inconsistent with such a result; inasmuch as they suppose the separate and independent existence of that Board for a length of time.

It would also appear desirable that before any final arrangements are made for the erection of Normal Establishments, the community at large should have an opportunity of

expressing their sentiments upon the question.

If however, it should be deemed advisable that Normal Institutions should be initiated previous to the opening of the next session of the Legislature, the Denominational School Board consider that with upwards of one hundred of the people's schools under their charge, they ought not to be precluded from any advantages which Normal Establishments may afford; but having no prospect of having any funds available during the year which will not be claimed by the immediate wants of Denominational Schools, (as will be seen Enclosure No. 2. by the annexed statement of their accounts), it will be quite out of their power to contribute towards Normal Institutions, without further provision being made from the public funds for

the purpose.

They conceive however, that it is their duty to avoid all unnecessary expenditure under present circumstances, and respectfully suggest that Government should give such instructions to both Boards as may prevent any steps being now taken, which may prove irreconcilable with the satisfactory adjustment of an improved system of public education.

SIR,

I have the honor, by direction of the Board of Commissioners of National Education, to inform you that they have it in contemplation to erect an extensive Normal School upon

the land in East Melbourne conveyed to them for that purpose.

2. The Commissioners duly impressed with the importance of proceeding with the initiation of this Institution without delay, have examined different plans which have been submitted to them, and are of opinion that the sum of Twenty Thousand Pounds might be advantageously expended at the present time upon the proposed building, which should provide suitable accommodation for Pupil and Training Teachers, and should contain large Model Schools for boys, girls, and infants.

3. Before however entering into permanent contracts, it has occurred to the Commissioners, that as the Denominational School Board have expressed themselves strongly in favor of the establishment of a system of Normal training for their Teachers, "on public principles," and as the erection of two large Normal Schools in Melbourne would appear to involve an unnecessary expenditure of public money, the Denominational School Board might be willing to devote a portion of the funds entrusted to them, towards assisting the Commissioners in carrying out the object on which they are both agreed.—They are confirmed in in this view by the consideration, that the secular instruction recognized by the Denominational School Board is identical with that promoted by the Commissioners; the same books and apparatus being used, and similar general regulations being enforced in the Schools of

The Commissioners have therefore desired me to make the following proposition, that is to say:—that the Denominational School Board should contribute a certain proportion, say two-fifths of the expense of erecting the Normal School Buildings, and that they should be entitled to nominate as Pupil or Training Teachers during say ten years after the opening of the institution, the same proportion of the whole number of Teachers which the Institution may be able to admit, upon the same terms and with the same advantages as Pupil or Training Teachers nominated by the National Board.

I am to request that you will have the goodness to submit this proposal to the Denominational School Board, and to obtain their decision thereon at your earliest convenience.
