
INTRODUCTION

Pursuant to the *Members of Parliament (Register of Interests) Act 1978* (No. 9223), Members are required to register their interests with the Clerk of the Parliaments by providing information under specific classifications. The classifications may be represented conveniently by the following abbreviated headings*:

- Income source
- Office held
- Company beneficial interest
- Party, body or association
- Trust beneficial interest
- Trusteeship
- Land beneficial interest
- Travel contribution
- Gift exceeding \$500
- Other substantial interest

Although each Member is required to submit an Ordinary Return on or within 60 days of 30 June in each year, section 6(4) of the Act also allows for notification of variations to the Register to be submitted at any time.

Since the Cumulative Summary of Returns — 30 September 2008, and the Summary of Primary Return — March 2009 and Summary of Variations notified between 9 October 2008 and 30 March 2009 were prepared, several Members have reported variations to the particulars registered in their names. The material which follows summarises under the abbreviated headings given above those notifications which have been received between 31 March 2009 and 24 June 2009.
